Introduction (Constantia, 12 Pt)

This guideline is a template for writing a research paper for SLR submission and this guideline is available online at the Author Guideline page on SLR official website. Authors are allowed to modify this template for submission purposes. Manuscript written with Constantia (12 Pt) with multiple line spacing at 1,2. The manuscript should contain at least 7.000 words including embedded figures and tables and the file should be in Microsoft Office (.doc/.docx). Manuscripts should be prepared in A4 paper (21cm x 29.7cm) using 4 cm for the left margin and 3 cm for the top, bottom, and right margin. No need to alter the page number in this template as the page number will be reordered during the preprinting process.

The introduction should explain novelty and contribution. Novelty is explained by comparing with three other articles, the author must explain the significant differences of the article (cannot differ only in the location of the research). Contribution is explained by explaining the benefits of this article for the scientific community, either for the national community or the international community (Optional.

Research Problems (Constantia, 12 Pt)

Type your manuscrip question here, First, how and Second, (avoid using the word what in the formulation of the problem; also not nuanced exam questions such as how the judge's consideration and only report the regulation)

Research Methods (Constantia, 12 Pt)

Explain the purpose of the article first, then describe the type and approach that is relevant to achieving that purpose. Give a detailed description of the data, not just mentioning primary, secondary, tertiary, or mentioning regulatory hierarchies. Primary data must explain how informants were selected and what interview subjects were used. Secondary data in the form of regulations, documents, or references must be detailed, and how to obtain the data. The final part must explain how the data is analyzed.

Discussion (Constantia, 12 Pt)

Results should be clear and concise. Discussion should explore the significance of the research. Avoid extensive citations and discussion of published literature.

If you must provide figures and a table, see below:

Figures

The figure should be in grayscale, and if it is made in color, it should be readable when it is later printed in grayscale. Caption should be numbered with Trebuchet MS 10 Pt and single-spaced. A caption should comprise a brief title (not on the figure itself) and a description of the illustration.




Figure 1. Figure Caption

Table

Number tables consecutively in accordance with their appearance in the text. Place footnotes to tables below the table body and indicate them with superscript lowercase letters. Avoid vertical rules. Be sparing in the use of tables and ensure that the data presented in tables do not duplicate results described elsewhere in the article.

SLR avoids articles that are organized without references in a paragraph. Paragraphs should be organized consistently, with one paragraph containing 5-7 sentences. Authors should avoid paragraphing in the form of pointers such as 1. 2. 3. etc or firstly, secondly, thirdly, etc unless it is only one paragraph.

Conclusion (Constantia, 12 Pt)

The main conclusions of the study may be presented in a short conclusion section. The conclusion section should lead the reader to the important matter of the paper.

Suggestion (Constantia, 12 Pt)

The author should provide suggestions or recommendations related to further research.

References (Constantia, 12 Pt)

Articles must fulfill a minimum of 20 primary references (journals or proceedings), the use of secondary references such as books, website releases, reports, etc. is still allowed but does not count towards the required 20 references from primary sources.

Use a reference manager such as Mendeley / Zotero, and make sure journal references have a DOI. Use the style of "Chicago Manual of Style 17th edition (full note)". The bibliography is not compiled manually, but generated from the reference manager.
