## **Terms and Conditions**

- 1. By submitting an entry, you fully and unconditionally agree to and accept these Official Rules.
- 2. Sweepstakes entries are limited to the United States and District of Columbia and is void where prohibited. All federal, state and local laws and regulations apply. Subject to any governmental approval that may be required, MCDC reserves the right to, without prior notice and at any time, terminate the Sweepstakes, in whole or in part, or modify Sweepstakes in any way, should any factor interfere with its proper conduct as contemplated by these Official Rules. Sweepstakes will begin on February 1, 2018 and will accept entries until February 28, 2018 at 4:30pm EST. MCDC reserves the right in its sole discretion, to cancel the sweepstakes in its entirety, if it becomes technically corrupted or because of non-authorized human intervention.
- 3. If injury, illness, death or damage occurs to any person(s) or property while the bicycle is in use, winners will have no right to make a claim or file a lawsuit against MCDC, its officers, agents or employees. MCDC cares about the safety of its patients, and encourages the use of a helmet at all times when the bicycle is in use.
- 4. Eligibility. Must be at least a legal United States resident 18 years of age or older who is the parent or legal guardian of a child age 10 & under. Employees, officers, or directors of MCDC, its affiliates, subsidiaries, and their children, parents, spouse, and members of their household

are ineligible to participate. No purchase or payment necessary. A purchase or payment does not enhance your chance of winning.

- 5. Effective date of entries. Entries will be effective on the day received. All entries become the exclusive property of MCDC and will not be acknowledged or returned. You are responsible for your costs of entering, including transportation to a participating MCDC dental center.
