at State and Federal Levels

This is a question of Freedom that affects everyone. If a precedence is established for taking our Freedom of Choice for the sake of Public Health when the risk to public health is almost non-existent, then the cause of Public Health will have the power to make decisions for you on issues where the risk is so much higher.

The Public Health Factor

Vaccination supporters point to the fact that choosing not to be vaccinated is a choice that doesn't just influence your own life. Not being vaccinated makes you a carrier that can infect those who are too young, too old or too sick to be vaccinated. Yes, your decision can have a direct impact on the health of others. Because of this fact, vaccine supporters want to make laws that make vaccinations mandatory for everyone except medical exemptions.

Following this same logic, smoking should be illegal because it kills over 41,000 non-smokers by secondhand smoke every year. Driving leads to 43,000 deaths every year, many of which are not the driver at fault. Firearms and Alcohol also claim the lives of thousands of innocent bystanders every year.

Rather than starting at the bottom of the list, (by enforcing laws to prevent the least threatening preventable causes of death in our society), let us first decide to tackle the most damaging public health concerns. But if we as a society choose to allow people the freedom to smoke, drive, drink, and receive medical attention at the risk of their own life and the life of others, then let them also weigh the risks and benefits of vaccinations and make that choice as well.

The Power of the Vaccine

"On January 23, the **Centers for Disease Control and Prevention** issued a health advisory to <u>address the</u> <u>recent multi-state measles outbreak</u> associated with travel to Disneyland in California. **The agency said 52 measles cases were associated with the outbreak, and 28 occurred in unvaccinated persons.**

...

Measles, in many ways, is the canary in the coal mine. It's the best indicator of the health of immunization right now, <u>because it's a very effective vaccine</u> and a very contagious virus." – <u>Vice News Article: We Asked an Expert What Would Happen if No One Got Vaccinated by Simon Davis</u>

Notice in this article Dr. Paul Offit, one of the most vocal vaccine advocates, tells us that the measles vaccine is very effective and a good indicator of what we can expect from immunization health. We learn from the Center for Disease Control (CDC) that there was an outbreak of Measles associated with travel to Disneyland, one of the worst places a disease could be released. **The outbreak infected 28 unvaccinated people and 24 vaccinated people.** This shows us that being vaccinated in no way ensures protection against the disease.

The Risks of Vaccination

Many experts like to pretend that there are no risks involved with vaccinations. They will tell you that there have been no direct links to long term side effects.

Health Resources & Services Administration (HRSA) is an agency of the U.S. Department of Health. They are responsible for managing the "National Vaccine Injury Compensation Program" which settles vaccine injury claims against private pharmaceutical companies outside of court to prevent expensive and public litigation for damages potentially caused by vaccinations. To date, the program has paid out over \$4 billion in compensation. This does not include court awarded compensation for injuries caused by vaccines.

The law firm of Maglio Christopher & Toale, P.A alone lists 611 personal court wins totaling over \$300 million in court awards for vaccine injuries. Many of the injuries listed were caused by the common yearly flu shot.

While there have been no formal studies on vaccinations, the Vaccine Safety Committee evaluated deaths that have occurred 7 days and 1 month after certain vaccinations and has concluded that there can be a causal relationship between vaccines and death. - (See Adverse Events Associated with Childhood Vaccines: Evidence Bearing on Causality. https://www.ncbi.nlm.nih.gov/books/NBK236284/)
