


Chronic Staff Positions

Division Leader

Has authority over:

Administrative Lead And below

Can do the following tasks:

- Do document work revolving around checking and making sure that the Administrative Leads are doing their work properly
- Can demote staff under the rank of Administrative Officer

Cannot do the following tasks:

- Cannot demote staff of the rank Administrative Lead - without the permission of Personnel Advisor

Administrative Lead

Has authority over:

Administrative Officer And below

Can do the following tasks:

- Can command Administrative Officer and below on what they need to get done
- Can perform document work revolving around LOA/ROA, staff applications, staff resignations, etc

Can promote a staff at the respective time (Meetings)

Cannot do the following tasks:

- Cannot demote staff without asking permission from the Division Manager
- Cannot perform any document work that is not in their category

Has authority over:

Lead Moderator

Trial Moderator

Can do the following tasks:

- Can Join Discord, TeamSpeak, And Forums Teams in the Infrastructure Department
- Can supervise Moderator and below to make sure they are doing their work, and following the rules and guidelines

Cannot do the following tasks:

- Cannot do any document work that's not given by the respected rank, if obtained a copy
- Cannot demote, or promote staff

Anything listed below is to be followed

Administrator

Has authority over:

- Trial Moderators
- Moderators

Can do the following tasks:

- Can ban in game members with the respected reasons
 - Can fill out document work based on their bans
- Have administrative perms in game such as spectating, ban hammer, etc

Cannot do the following tasks:

- Cannot do document work that doesn't relate to their staff abilities
 - Cannot tell any staff or members of the community to give out any passwords, or personal information, that's not dealing with one of their problems, questions, or concerns
 - Cannot demote, or promote staff

Anything listed below is to be followed

Lead Moderator

Has authority over:

Trial Moderators

Can do the following tasks:

- Strongly advise Trial Moderators to do their work and assist them
 - Can join certain Infrastructure, Affairs, and Personnel Teams

Cannot do the following tasks:

- Punish CRN Staff, or members
- Can't fill out any document work that's not within their permissions
 - Cannot tell any staff or members of the community to give out any passwords, or personal information, that's not dealing with one of their problems, questions, or concerns
 - Cannot demote, or promote staff

Anything listed below is to be followed

Moderator

Has authority over:

Noone

Can do the following tasks:

- Can advise rules, and guidelines to trial moderators and members of the community
- Has the ability to join CRN Teams, given permission from the respected rank
 - Can mute players in game, and do the required document work

Cannot do the following tasks:

- Do document work over then their required work
 - Cannot punish CRN Staff, or members
 - Cannot force Trial Moderators to do their work
- Cannot tell any staff or members of the community to give out any passwords, or personal information, that's not dealing with one of their problems, questions, or concerns
 - Cannot demote, or promote staff

Anything listed below is to be followed

Trial Moderator

Has authority over:

- Noone

Can do the following tasks:

- Is required to help players ingame, and through the teamspeak, and discord
- Report any suspicious activity, bugs, cheaters, etc to the appropriate rank

Cannot do the following tasks:

- Can't fill out any document work
- Can't give any ingame punishments
- Can't join any CRN teams, without permission from the respective ranks
 - Cannot tell any staff or members of the community to give out any passwords, or personal information, that's not dealing with one of their problems, questions, or concerns
 - Cannot demote, or promote staff
