- Any attendees, how did it go?
- That's why nobody is here!
- Vendors / source code scanning
  - When working with vendors, what kind of scrutiny does your OSPO put on code coming in or being worked on after it comes from a vendor?
  - Stockholm OSPOlogy mentioned this in relation to AI
    - Is Al under the OSPO?
    - Under Security?
  - How does an OSPO assess incoming tech assets?
    - Apparently, from that discussion, not a lot of consensus.
  - Add up a bunch of projects that are coming in, and rank them
    - Helps understand what dependencies are coming in that could be problematic or worth assessing
  - Could scan as soon as it enters the company, as a policy
    - Developers would check in code and it would do an inbound check on licensing.
    - Built off of SPDX 2.0 specification
- Maven Central / using in-house repository managers
  - o 83% of traffic was coming from just 1% of IP Addresses!
  - Rate limiting coming soon
  - Tangentially related: How much do OSPO's get involved with build infrastructure? Is this something anyone in this group is building ideas and structures around?
  - Anecdotally:
    - Caching may come from InfoSec or AppSec so we have good supply chain security
    - OSPO doesn't own it but interfaces with AppSec for guidance / direction on using the proxy
  - o Is there a "Java-ness" to this problem?
  - PIP / homebrew also have similar problems as small projects it's felt a lot.

Given the privacy and data quality constraints on company membership, it will never scale to be useful for evaluating potential packages. | Instead, it might be better to track a bunch of repositories that have had the negative events that you are worried about and then back out predictive metrics from DDS (distributive developer score), issue/pull-request resolution rates for contributors who don't approve PRs, etc. Examples of negative scenarios that could be identified in bulk include: archived repos, license changes, unmerged pull requests.
      - Summary: rather than trying to measure org membership with its privacy and data quality issues, it might be better to go straight to the negative



events that you're worried about happening and identify preceding conditions for those events instead.

- Predicting failure modes / risk for example can we predict if a project is going 'change a license'
- how to draw boundaries around classifications (what is a project?) how do we classify things using data, rather than using intuition. A range is better than nothing. Can only be solved by large scale modeling.
  - Examples: what repositories should we include in a project? (can we know this without asking a maintainer?) what stage is the project in? (growth, stability, decline)

    - There will be a session at FOSSY about <u>AI and Open Source</u> (Brian Proffit)
    - Governance: The same set of people who are discussing AI, are also discussing open source. This overlap draws in the legal components of some organizations. The risks go well beyond the usual compliance risks.
