

##Rescheduling of Controlled Substances Act##

Whereas, the scheduling of certain substances in the Controlled Substances Act (CSA) includes substances of low abuse potential in the improper scheduling category

Whereas, the medical and psychological applications of some substances are prevented from being utilized due to improper scheduling

Whereas, psychedelic substances do not lead to a dependency on said substances

Whereas, the improper scheduling of some substances leads to people being imprisoned for non-violent offenses

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

###Section I. Short Title:##

This bill shall be referred to as the RCSA

###Section II. Amendments to CSA:##

> (a) Under Title 21 of the United States Code (USC), Chapter 23, Subchapter I, Part B, Section 812 (b) the Controlled Substances Act shall be amended as follows:

>> (i) The following substances shall be rescheduled from Schedule I to Schedule II:

>>> (1) MDMA (Methylenedioxymethamphetamine)

>> (ii) The following substances shall be rescheduled from Schedule I to Schedule III:

>>> (1) DMT (dimethyltryptamine)

>>> (2) LSD (lysergic acid diethylamide)

>>> (3) 3,4,5-trimethoxyphenethylamine (Mescaline)

>>> (4) Peyote (**Lophophora williamsii**)

>>> (5) Psilocybin and psilocin

>(b) The following substances, which are analogs of the above-listed substances for the purposes of the Federal Analog Act, but which have been explicitly scheduled themselves, shall be rescheduled from Schedule I to Schedule III:

>> (i) The serotonin homologs alpha-ethyltryptamine (αET) and alpha-methyltryptamine (αMT).

>> (ii) The DMT homolog DET, and 5-MeO-DIPT, a positional isomer of DMT's isopropyl homolog (DIPT).

>> (iii) The alpha-methylated mescaline homolog TMA and its positional isomers.

>> (iv) The 2,5-dimethoxy- series of MDMA analogs: DOB, DOA, DOE, and DOM.

>> (v) The "2C" substances, the 2-carbon homologs of the family of substances in subsection (b)(3) above, being: 2C-B, 2C-T-7, 2C-E, 2C-D, 2C-C, 2C-I, 2C-T-2, 2C-T-4, 2C-H, 2C-N, and 2C-P.

>> (vi) The MDMA analogs PMA, MMDA, MDA, MDEA, N-hydroxy MDA, and the beta-ketone homolog of MDMA, methylone.

*****Section IV. Enactment:****

This bill shall take effect immediately upon signing into law.
