I'm an instructor and the founder of Accountlandia, and I'm very excited today to have a special guest Lisvan Carvajal Alvarez. He was a former student at Portland Community College and I had him in several classes. He ended up applying for a really special opportunity through Multnomah County, called College to Career Internships and he's going to talk to us about how they work, what his experience was with them. OK. Hello, everybody. Thank you Cynthia for giving me the opportunity to provide some feedback about this experience. I'm really happy to share with the community about everything that I have lived since I start my internship at.

Everyone always wants to know a person's PCC story. What brought you to Portland Community College, and specifically what made you decide to major in accounting.

Well, umm, my story is kind of similar to other specs. Students uhm, in a way that I'm originally from Cuba, I came over to the United States seven years ago as a refugee. By the time I landed here in Portland, which was and has been my hometown since then.

I didn't know how to say a word in English. Nothing. Zero word in English, not even. Yes, I start looking for opportunities and school, you know, for as a second language. And all these things since the PCC was so much reportable at the time, was kind of the same reference.

Then I start in level one in the ES ESO classes program at PCC, so I navigate the whole program and after three years I was able to complete it. It was a hard journey because it was very challenging just to incorporate. We can acquire more language skills, but here I am after seven years talking to you and hopefully being able to convey the right message and in the right language skills. That was the first step in time at PCC.

Afterwards I was able to enroll in the career pathway program and then I start my accounting pathway at PCC. Well why accounting because in my home country, Cuba, I got a degree in business administration and when I tried to transfer my skills and my previous knowledge, I found. Now that accounting and business administration where the two fields you know closest related and I start there. With the objective of getting my associate degree in accounting or business administration, they are very similar, but it turns out that I enroll in the career pathway program and I was able to complete one year certificate as an accounting clerk. It took me longer than one year because I combined work with the school. You know, I wasn't able to do full time schooling, but I was able to complete my my accounting certificate. I am taking a break. But uh, I will come back at certain point to try to to complete my associate degree. This is my academic journey in my lifetime right now.

Well, as a normal life and like you know, most of individuals. And while I was doing a school.I was trying to get better jobs. And I tried to to use my my accounting skills to land in accounting jobs. But then the dilemma came up when I tried to apply for jobs. I found out that there were two challenges for me. One jobs mostly required high experience in addition to higher education.

I certainly made one of those, but not both at the same time, so I wasn't eligible for many, many, many accounting jobs just because I was doing a school. But having been having experience on the field, right, or I had a certain background. But I didn't have any certificate or any degree in accounting to make me, you know, qualify for that job. It was a very challenging time because I applied on and on and on and on.

It didn't happen and then was when I started looking for internship opportunities in order to combine, you know, and acquire on the field some experience while getting some payment and then, you know, go slower but goes going slower but getting both job and experience while I was completing my programs right?

There was something that I gotta say to the public and all the audience that changed the dynamic in the accounting community at PC and it was the amazing creation of Accountlandia. Yeah, that was a breaking point. That was a breaking through. Thank you to you, Cynthia and anybody that work or and has been working on this fantastic idea in all these.

Years I was before Accountlandia and I have been afterwards, so I can't compare how different was how our opportunities at the time there were. There were just a few. I mean all the content and everything wasn't contained as it is, it wasn't so as informative as it is right now. So, Accountlandia just change all that through Accountlandia, I got the advertisement for the internship at the Multnomah County. I went through the whole process and I applied.

The application itself wasn't challenging because as an intern, they didn't require too much. They understood and they understand and just talking from being on the other side already, they understand that you are not fully prepared or that you don't meet all the qualifications and and educational requirements that a normal position would require from you as a permanent employee. That's one thing for me.

Challenging was creating a cover letter and publishing my resume, which I was able to do it going through our specialist, I remember Nicole, I think it was the the amazing especially help me out with my resume and and working on my cover letter and and then I submit all the paperwork and I got the interview. The interview was OK, the interview challenging every time I try to be myself was honest. I tried to highlight all my skills, you know, not only the technical skills because they were reflected on my resume and the cover letter.

But who I was and what I was bringing to this new work space and it, and it has to do more. Who with who? You are. What? What commitment? You show what determination you show, what they think that is meaningful from there. From then, just to allow you allow you to go there,

it was a very competitive process because they were applicants from all over the state. Even from, you know, Oregon State University and PSU. And I think I was the only PCC student at the time and this is something that I wanted to talk about later but that was the whole process, right. And then I finally got the approval right? I mean it was a super great news to me and and then I start my internship. The internship that I applied to was in the County Management Department in the Division of Recording, Taxation and Assessment.

So property taxes probably, right?

Yes, this is the division and the department who collect all the money that funds the county, the property taxes, property appraisal, passports, license, permit. All those items are run and are managed by this division. I landed in the residential appraiser department. I was assigned to a project which was about evaluating condominiums, parking spots and all these things, and I start from scratch. I was assigned to a mentor and a supervisor.

After two months, as I said at the beginning they offer me just to stay, which is kind. Of a big opportunity that you have there along with other ones, let me tell you how the internship, it's kind of a structure. So first of all when we as a student when we go to this kind of first opportunity we go extremely focus on showing our technical skills to the people we need. We want to let them know how good we are, our accounting skill or how much we are able to learn and develop on the accounting type.

They are not concerned about that. They want to provide to you. They are not demanding from you. And how does it translate in the internship, for example, the internship is a structuring orientation, orientation sessions. It happens every other week or every week. It depends. When you get together with all the interns that are working in the county, there you have speakers. You are introduced to programs you have. You have taught how to write your resume, how to prepare for your interviews, how to do cover letters and all your supervisor allow you to go. This is part of the program.

They know how every single supervisors that work there, they know how the program runs and they they are aware of that. You are not gonna be strictly working all the time on their on your project. Your project is a reason for you to be there. But what it makes more sense for them is for you to get prepared. They are preparing you right? So orientation section you have peer-to-peer section when you interact with other interns and just to get input from their experience you getting signed information you create connection, you network a lot and you get enrolled with other programs you meet county employees. It's super interactive and it's super good for you to to make connections for you to to create, you know, future future network. That's another.

Thing, you have assign through a pool that you run. You are assigned to a mentor. This mentor is able to meet you as many times as you need just to answer technical question, just to lead

you through the potential pathway you can follow what specialties in the county or in the discipline you are studying for are available or are good. Or what other opportunities related to to accounting, you can go for. Without strictly work in an accounting environment, let's say behind a computer in a parallel for eight hours, right, there are so much more. This is governmental level. This is not, you know, private sector or accounting firm. Here accounting is more about budgeting.

This summer is more about evaluation. These kind of things, at least in the department that I was working in. It's not about auditing or it's about other accounting skills. What's really important at the time among all these good things that the internship provide.

The payment was very generous, even in a permanent job, I was able to get at highest paid as I got in this internship. It meant a lot financially to me. You know, it was a relief. I was able to focus because I was able to cover all my needs and my expense. Keep doing my school and being very committed to to complete my project at the accounting.

This is the how the county internship is structured and most of the take away that I got from from my experience in the in those two months.

There were a number of shelters activated for people who weren't able to afford a warm place to be and and or or or or security or and, and we were given the opportunity to go there as a staff taking care of that people, feeding them, welcoming them, looking out for them, providing resources for them. And I remember myself driving in all these bad weather conditions where the roadway were very bad to drive on and I was committed to do that.

I went. I was able to see how my effort, my work impact others life. Other people that didn't have resources didn't have anywhere to go. They were struggling and I was thinking for a minute. Could you imagine these people on the county provided from them? And I was there to support.

First advice is for accounting students overall is that it's a big deal sust to combine the education part with experience on the field, just to go growing in on both sizes, even when you go slower, you are rounding and shaping a better asset for the job market. That's my first piece of advice.

Secondly, when you go to the application, it is hard process, but you get some help with the account with the PCC specialist that can help you. Just working on your resume and your cover letter. That's not the most important thing because at the end you are able to write down everything that you have work and on and everything you have accomplished in life that could make you a good candidate. When you go to the interview beside to follow all the protocols and all the standards and all the amazing thing that we are taught to do. Be yourself, show who you are from the heart. Those people know they are in front of a different individual. They know that. And then when you finally go through and ensure all the PCV applicants have everything just to be an intern for them, Multnomah County.

Once you go there trying to learn as much as you can but know about the technical stuff in first place know about how to interact and work in a workplace, know how to connect with others, learn how the culture is. Try to make all the connections you want and you can and then decide if you want an extension. You have the opportunity to ask to your, to your supervisor for an extension. They will be very happy if you wanted to land as a full time employee with them.
