- 9. The CAPC Director requests authorization to attend the San Diego International Conference on Child and Family Maltreatment that will take place on January 29-February 3, 2016. The Registration fee for this conference is \$515 if made before 11-18-2015. After that date the registration fee is \$615. The total cost of the training not to exceed \$2000 that includes room, per diem, registration, travel and parking. It is recommended that this expense be drawn from the KIDSPLATE account.

V. Additional Autumn Training: Charles Appelstein

The Director introduced the item.

We held a highly successful training with our Army community Service, CASA, Hartnell College and CAPC collaborative. We planned for 100 participants and 140 attendees showed up! Charlie was "on" his game and it was a highly educational instructive training with an important message. Charlie is returning to the Bay Area later in the year working with members of the Greater Bay Area CAPC Coalition. He is willing to deliver one day two-session training at a reduced fee sans expenses (since he is already here). His fee is \$1600 for the day.

CAPC will fund the training. I am considering smaller sites aimed at two populations: **the Department of Probation and the Department of Social Services.** Initial conversations with Lori Medina and Marcia Parsons, both members of the CAPC, indicate interest in the training.

Appelstein's main message is delivered in one three hour session. I am proposing two three hour sessions, one in the morning and one in the afternoon. Sites convenient to our target populations will be chosen. Because these are shorter, smaller sessions we will not have to provide Continental breakfast or lunch for attendees. This is a great opportunity to provide a nationally renowned trainer with an important message for a minimum expenditure.

After minimal discussion:

It was moved that CAPC authorizes expenditure not to exceed \$2000 to cover conference expenses for the Charles Appelstein Strength Based Parenting Program. It is recommended that all expenses for this training be drawn from the KIDSPLATE account. It passed unanimously.

VI. Labor of Love Report-the CAPC Director delivered a report on the number of attendees and the results for our support for the Labor of Love 2016.

VII. Perinatal Depression-Gail Root presented her program to provide services to women who suffer from Perinatal Depression (Post Partum Depression). It is considered one of the top five causes of child abuse by studies from Health and Human Services in Washington, D.C.

Perinatal depression is common and primary care holds a crucial role for detecting, treating or, if necessary, providing referrals to mental health care for affected women. Family doctors should be aware of risk factors for peripartum depression, including previous history of depression, life events and interpersonal conflict. Perinatal depression has been associated with many poor outcomes, including maternal, child and family unit challenges. Infants and young children of perinatally depressed mothers are more likely to have a difficult temperament, as well as cognitive and emotional delays.

If depression continues post-partum, there is an increased risk of poor mother—infant attachment, delayed cognitive and linguistic skills in the infant, impaired emotional development and risk for behavioral problems in later life. (This brief abstract is from an article on Mental Health in Family Medicine.)

At the conclusion of her report, Ms. Root took questions from the CAPC members. After discussion:

With a motion by Pennycook/Murtagh the CAPC authorized the Director to contract with the Parenting Connection to provide three (3) months funding @ \$1000 per month to support the Perinatal Mood and Anxiety Disorder support groups for parents during pregnancy and the post-pregnancy period. CAPC recommends that this funding be drawn from the KIDSPLATE reserve. The motion passed unanimously.

The CAPC also recommends that the contract include an evaluation and "report-back" element as to the success of the program.

VIII. The Director introduced Robin Leppo-Kerr, who serves as the newly appointed Executive Director of the YWCA of Monterey County. Robin presented a PowerPoint program that informed the CAPC about a project she worked with when she served as the CAPC Director in Madera County. It is called Grace City (PowerPoint available upon request):

A centralized, user-friendly mobile resource app allowing immediate access to short- and long-term services for exploited and high-risk individuals.

Law Enforcement/First Responders/Social Workers/Case Managers/Advocates/Pastors/Chaplains/Medical Professionals/Teachers/Counselors/Therapists/Agencies/Organizations
