

Ethics/Criminal Complaint Libby Wennstrom, Port Townsend City Council

This is **the Second time of sending this Ethics/Criminal Complaint against Councilwoman Libby Wennstrom**. I have received no communications as to the progress of this complaint or if the City of Port Townsend has taken any of it seriously. Therefore I am sending this complaint again, with updated allegations.

This will all come out in the Legal System, even if the City of Port Townsend, Jefferson County Sheriff and Port Townsend Police Chief do nothing to investigate these crimes and constitutional rights violations. There will be Federal Hate Crimes and Federal investigations for offshore activity. The City of Port Townsend cannot claim "Clean Hands". As **I have notified this body of government repeatedly**.

Port Townsend City Council Member Targets Elder Woman, Bullies, Incites Violence.

Ethics/Criminal Complaint by Reverend Crystal Cox into how it came about that an entire community attacked elders, lesbians, minorities in the streets of Port Townsend, and covered up the events that took place. This public records information is in regard to councilwoman Libby Wennstrom.

Yes City Manager John Mauro sided with the YMCA within the first 24 hours with NO Investigation and spread a false narrative among city officials, however, Mauro did not invite nor incite the mob, Councilwoman Libby Wennstrom did.

Councilwoman Libby Wennstrom, per public records, incited a mob against local 80 year old resident Julie Jaman. Wennstrom invited Unitarian Church members, Jason Serinus and all those in the community connected to their LGBTQ groups, to come to the YMCA and protest, shutting down the free speech rights of Julie Jaman. Wennstrom brought her "Crew" "Team" Salish Rescue, and the mob she incited and invited to Amy Sousa's permitted Women's Speaking Event August 15, 2022.

This attack on women's rights and free speech had had massive after effects, as the community at large still believes Councilwoman Libby Wennstrom's version of the narrative. We are still under constant verbal attacks and fear in public.

Libby Wennstrom and Rowen DeLuna have been friends for decades and DeLuna is now also on the board of Libby's nonprofit Salish Rescue. Wennstrom sided with DeLuna immediately, as a sitting councilwoman with no investigation into what really happened. Libby Wennstrom fed the community a false narrative and incited hatred toward Julie Jaman. This translated as hate to Amy Sousa and any of us who went to speak at Amy's press conference or city council that night. The Hate continues via articles in magazines, city council comments, Port Townsend Leader defamation and hate by Jason Serinus.

Libby Wennstrom as per public record got her "Crew" "Team" to come to Amy Sousa's permitted event on city property and to bully us, intimidate us, shut down our free speech. This Crew was Salish Rescue Alden Rohrer, Kevin Schooler, Elijah Urner (or Johnston) was taking drone footage and other Salish Rescue "team" members were there threatening us, screaming at us, putting flags over our face and coordinating others to do the same. This is all in video and public records.

Salish Rescue is a Washington State NonProfit, UBI Number: 604 127 963'
Salish Rescue was acting outside of its Mission Stated to the IRS which is :

I am filing complaints with the IRS, the Attorney General, Coast Guard, Homeland Security, DOJ and more on this issue. Salish Rescue false reports assets, lies about volunteers not being paid, bullies people they rescue and has multiple rape allegations over years, sets up former operators, sinks boats deliberately, bullies ship owners they have helped for LIFE. This is Serious and the Port Townsend Community needs to be aware. Instead the City simply blames me, the messenger and one of their victims, and IGNORES the Truth, thereby deliberately continuing to put people, property, ships, lives and rights in danger.

Councilwoman Wennstrom had her own "crew" at Amy Sousa's Press Conference. The "he" she is referring to below is Port Townsend City Manager John Mauro.

He got it into his head that I "had hired private security" because the local crew were organizing.

This leads me to believe City Manager John Mauro knew that Salish Rescue would be there bullying us and violating our rights. Public Records show that on August 8th, 2022 Salish Rescue's TEAM met with Chief Tom Olson. PTPD knew that Salish Rescue would be there, with body armor, guns, drones, and coordinating a mob to shut down our speech.

Councilwoman Wennstrom admits that the Port Townsend Police deliberately "blew this off for 10 days" and was not prepared. Libby admits her "crew" was ready. Councilwoman Libby Wennstrom had a concealed carry, gunshot trauma packs and body armor that night. Though she told members of the public in private messages that she had received no threats.

On July 27th, 2022, Julie Jaman, an 80 year old, 40 year Port Townsend resident, and Elder in our community, had been swimming at the local YMCA. The YMCA is on city property and is under contract to manage the property independently of the city of Port Townsend.

For me there is nothing an 80 year old woman could EVER say that would make me incite violence upon her, protest her, hurt her, try and deny her right to be heard.

Throughout time, generations have clashed. Elder women have yelled at me for the clothes I wear, using too much salt, the music I listen to, who I hang out with, giving them the wrong pastry when waitressing, being a lesbian and so much more over decades. So what. I may have made a comment, or expressed my view, but I would never have incited a hateful campaign against the elder. To me the YMCA issue was easy, with compassion, strong leadership, love, and true equality with no agenda, politics, prior opinions or prejudices, the matter would have been solved quickly and quietly. All management had to do was apply common sense and the golden rule, instead personal prejudices literally created an international incident. The city of Port Townsend should not have been involved in YMCA policy in any way, as per their operating agreement contract.

City manager John Mauro knew and knows that Libby Wennstrom is a gaslighting bully, as just the day before he had emailed mayor David Faber about Libby bullying city staff. Mauro

In an effort to ensure we're all synced up, I often get a heads up and a brief update from my team when Councilmembers reach out to them, especially if I'm not cc'd. I like this system so that Councilmembers can ask questions and have easy access to information to help them do their jobs but color within the legal lines of not directing staff. It's also great to have staff enjoy direct relationships with elected members since we spend a good amount of time and effort together and I'm not wanting to command and control those relationships. This balance is new for the City I'm told and one that I think we and our community can benefit from.

That said, there are ways this can go poorly, hence this email heads up. Our People & Performance/HR Director indicated that Councilmember Wennstrom contacted her last week to discuss a media matter related to my performance review. Councilmember Wennstrom is within her right to ask questions and reach out (I've often urged her to contact directors for more information on other matters). I get the sense from my HR director, though, that while it ended okay, the conversation started poorly and with some degree of accusation. This is troubling to me for at least

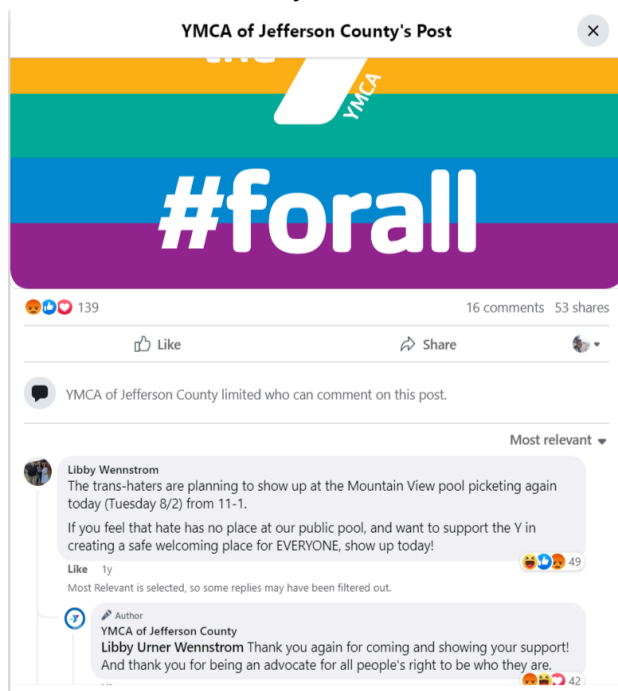

August 2, 2022, Julie Jaman was exercising her First Amendment rights, and held a small sign with a couple of other community Elders, in front of the YMCA, for a couple of hours. Councilwoman Wennstrom, who took an oath to uphold our constitutional rights, put out a call to action for those in the community to come to the YMCA to protest and bully Julie Jaman, get in the way of Free Speech rights, and incite hate against this long time Elder in our community. Libby called Julie a trans-hater, of which she was not. The YMCA was thus not a safe place for everyone, and certainly not standing for all.

Julie Jaman had a right to Equality, no matter her views, opinions, beliefs or personal choices. Not only did councilwoman Wennstrom put out this call to the community, she, as a public servant, went to city property, a nonprofit that the city was under contract with and protested Julie Jaman's rights in person. Libby incited hate in our community, and divided community members and seriously divided the LGBTQ community.



Julie Jaman went to city council **August 1, 2022** and expressed her concerns, as a citizen of our community. Libby Wennstrom called it a “shit show”. Libby incited hate and violence in the community and flat out lied to the public, misleading them about what Julie actually said. This hatred began to grow in Port Townsend and beyond and would later lead to real world violence, civil and constitutional rights violations, human rights violations and hate crimes against those of us who went to speak at the August 15, 2022 council meeting as was our due process right. Libby Wennstrom’s “crew” and community members she helped incite, blocked us out of the

council meeting, physically. Denying our right to due process, and our voice. Libby called those who came to participate in a city council meeting, bigots.

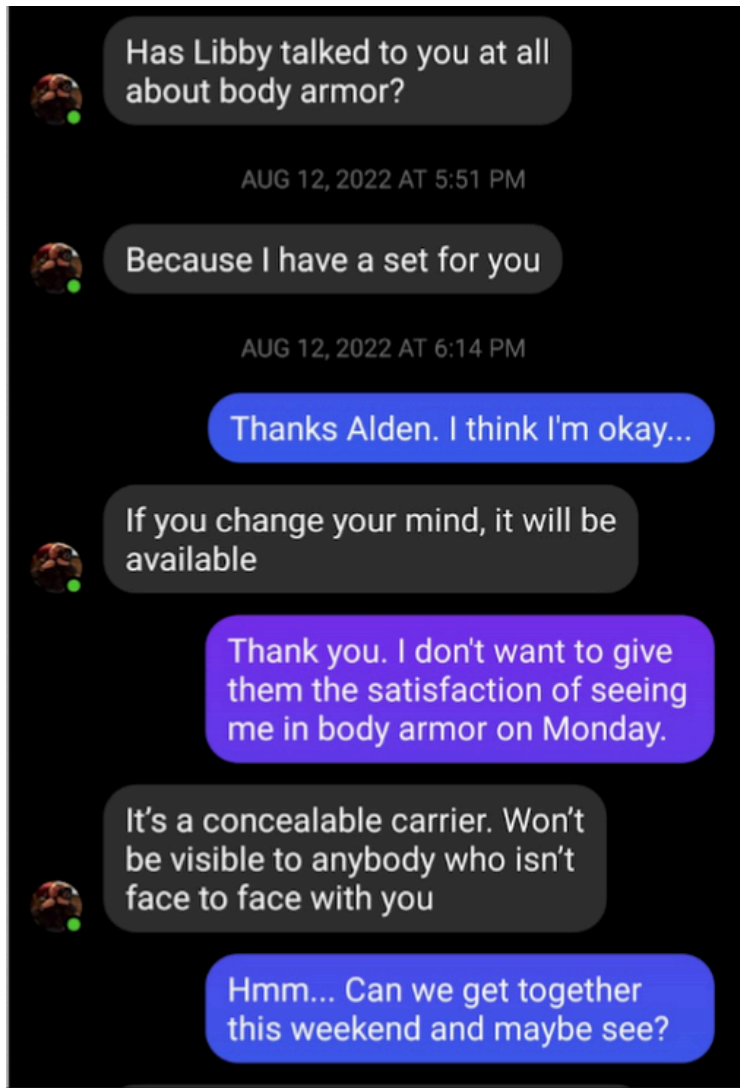

The night before Amy Sousa's Press Conference, Libby was organizing her protest shirt, hate campaign and discussing a "proxy war" with local resident Julia Cochrane in public record messages. However Olson hated us, prejudiced us prior and lied about our assault, gaslighted us after. The police that obeyed Chief Olson and NOT their constitutional oath were also not “prepped”. I’ve never said anything remotely like “all TERFS leave the city”

I did share widely circulated a sticker image that someone else had created showing the Tsunami logo in pink, and the text “TERFS Out”

While the sticker design was intended to be a pun on “Surf& Turf” and bringing some humor to the idea that the “tide was turning” on hurtful stereotypes about Transgender people, I understand that some have tried to cast this as my “beliefs that TERFs should be “driven out” of “my” town. In hindsight, it wasn’t helpful to share it and created more upset and more extreme behavior.

Councilwoman Libby Wennstrom affected our safety, put fear into us, intimidated us then misled the public that instead we were the bullies, bigots

Let me state this clearly: people are entitled to their opinions, however bigoted or hurtful I personally may find those opinions. The line where that stops for me is where that “opinion” denies someone else’s right to exist and live their life safely.

Having an opinion that black people are inferior and are all criminals is protected free speech. Lynching them, harassing their children, or sending them threats is a crime.

Having a opinion that women aren’t suited to elected leadership is protected free speech. Keeping them from voting or holding office or intimidating them from running out of fear for their personal safety isn’t an opinion, it’s harassment.

Similarly, having an opinion that transgender women are only pretending to be women in order to prey on unsuspecting women in locker rooms is an opinion. Screaming at transgender women and asking questions about their genitals is harassment. There’s a line there.

I am taking a hard line about this issue precisely because I see firsthand the harm it is causing. A 19 year old is having to quit her job, drop out of school, and leave her community and family in order to not have to live in fear of actual, credible death threats.

Dozens of parents were without childcare for more than a week because the Y was closed because of threats against the facility and staff, out of concern for children’s safety. Nobody wants an Oklahoma City bombing situation.

The Y aquatics director is receiving photos of her children with “they’re next” and has had to buy body armor and always travel with a protective detail.

The city offices were basically unable to function normally for days because all phone lines were jammed. Totally random city employees were being literally screamed at. The person who answers the phone for the water department does not deserve obscene verbal abuse.

We were lynched, harassed, hit, kicked, bullied and our rights shut down in part by Libby’s action and Libby’s “crew” was directly involved in our coordinated attack. Libby plays victim when she incited the violence in the first few days with her own hatred, prejudice of Julie Jaman and joining a protest against her, as a representative of the City of Port Townsend. Libby cost the city thousands upon thousands, not us.

Libby told friends in private that she had no threats, then lied in a public comment response, as a city representative, that there were hundreds of threats. 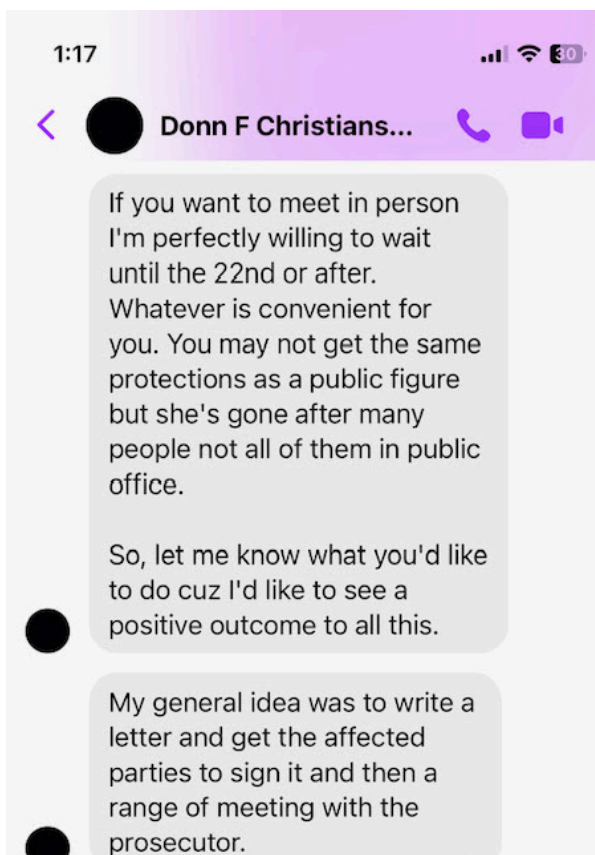

Salish Rescue led by Libby Wennstrom, is a Danger to our Community. They actively gangstalk any of us who they do not like for any reason. By this I mean they work on getting protective orders, they tell authorities we are mentally unwell, crazy, and mentally unstable. They act in a group to shut down youtube accounts, twitter sites, and Facebook Pages. 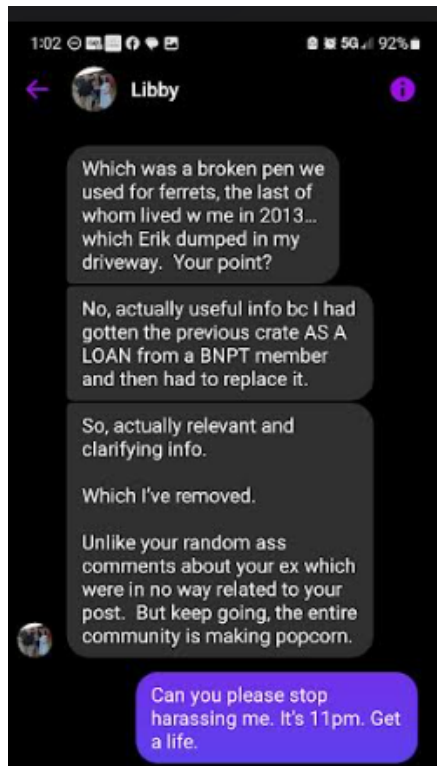

Instead Libby kept telling them I was crazy and he was a hero. They dropped me off at Dove house and said nothing more to me. Never contacted me again.

A person can be both. You can be a woman beater and still go out and save lives. I spent 2 years of my life saving lives with him through Salish. He did do that.

That last year when he started forcing me to do things I didn't want I went to Libby repeatedly and begged for help. She told me to suck it up. That it was in my head and that he was a good guy. My bruises, my ripped out hair stated a different story. She refused to listen or look. When I showed her a text where he went off verbally she said it was my fault for staying with him. I was asking a fellow woman for help.

Turns out they were sleeping together. Go figure. Finding his clothes in her bedroom was my clue, among others.

There's a video he used to get that order against you Erik. It damns him. It proves he's been manipulating me to this day still. He will never let me go.

He tried to manipulate me by stealing my own property, then told me in the video it wasn't mine. Even though I have texts from you saying it is my dumpster. Tried to force me to use my truck to go get that engine at your place to get my own property back. It's in that video he stupidity used to get you in jail. He still has my stolen dumpster.

The video where I lied to him. Gave him false information. Why? You try standing in front of your abuser. The man who forces you to meet with him monthly to talk about how he's going to give you your stuff he's holding hostage in Ninaa, if you just do what he says. Salish towed you to Glen Cove, suggesting strongly you anchor in shallow water for ease of recovery if the pumps couldn't keep up. You refused, insisting on anchoring deep.

Salish volunteers and others spent two full days in the wet cold dark helping you with patching, logistics and transport.

Salish Rescue lent you thousands of dollars worth of pumps and equipment and strongly suggested you keep someone on board 24/7 to refuel pumps. You ignored advice, left the boat for 10 hours, pumps stopped running and boat sank.

You then left town for over a week, leaving your boat sitting on the bottom.

Remind me how this is anyone's fault but yours?

Remind me how exactly Salish is profiting here?

I understand that you're in a tough situation. But every single decision you've made has actively made the problem worse. And now you're lashing out at people who've spent the last two years trying to help you.

Elijah Johnson also told Libby and Erik about another lender who had raped someone. Erik and Libby both said if she didn't go to the police they didn't care and she is probably lying. Erik said this to her face. Wtf. Then Libby backed him. There's message logs of this. I have screenshots like wtf Salish Rescue? I have voice recording of this. WTF Salish rescue is full of rapist? Fucking a get your shit together, am I right everyone?

Fraud on the Courts
