

FAQ: Parent Opt-Out Rights Regarding Instructional Content

Based on Education Code 49091.10–49091.14 and *Mahmoud v. Taylor* (2025)

Q1: What is *Mahmoud v. Taylor* and how does it affect my rights as a parent?

A1: In *Mahmoud v. Taylor* (2025), the U.S. Supreme Court reaffirmed that parents have a constitutionally protected right to direct the religious upbringing of their children. The decision clarified that public schools must accommodate **opt-out requests** from parents when instructional content **substantially conflicts with their sincerely held religious beliefs**, provided the accommodation does not disrupt core academic objectives.

Q2: What instructional content can I opt my child out of?

A2: Under California law and *Mahmoud v. Taylor*, parents/guardians may request to opt their child out of specific lessons, books, projects, or assemblies that substantially conflict with their family’s religious beliefs. Examples might include:

- Storybooks or curriculum materials about identity, family structure, or belief systems
 - Activities or discussions that promote views incompatible with your religious values

Q3: Can I opt out of any part of the curriculum for any reason?

A3: No. Opt-outs must be based on a **sincerely held religious belief**. Philosophical or political objections may not qualify under current laws or the *Mahmoud v. Taylor* decision. Schools are not obligated to grant opt-outs that interfere with core academic standards.

Q4: What grades or students does this apply to?

A4: In most cases, opt-out rights based on religious belief apply to **elementary students (TK–Grade 4)**. Middle school content (Grades 5–8) may be subject to different rules unless otherwise specified by state or district policy.

Q5: How do I request an opt-out for my child?

A5: You must submit a **Parental Religious Opt-Out Request Form**, which includes:

1. Identification of the specific content (lesson, book, etc.)
2. A description of the religious belief that conflicts with the content
3. A suggested alternative assignment that aligns with academic standards

Return the completed form to your child's school by the listed deadline. The request will be reviewed by school administration.

Q6: What happens if my opt-out request is approved?

A6: Your child will be excused from the identified content and provided with an **alternative educational activity** designed to meet the same academic goals without conflicting with your religious beliefs.

Q7: Will my child be penalized or treated differently?

A7: No. State and federal law prohibit discrimination, penalties, or negative academic consequences for students who are granted a religious opt-out.

Q8: Can I review the materials before submitting an opt-out request?

A8: Yes. Education Code 49091.10 and 49091.14 give parents the right to **review instructional materials** in advance. These are available for inspection at the school site. A course prospectus is also available upon request.
