Salary Requirements

Minimum Salary Threshold: The applicant must either meet the general salary threshold of £26,200 per year or the "going rate" for the specific job, as determined by the Home Office.

If the job is on the Shortage Occupation List, the lower threshold may apply, typically £20,960 per year.

Lower Salary Options: Candidates may qualify for a reduced salary threshold if they are in certain occupations, are new graduates, or if their job is in a shortage occupation.

English Language Proficiency

Language Requirement: Applicants must prove their ability to communicate in English at least at a B1 level on the Common European Framework of Reference for Languages (CEFR). This can be demonstrated through:

Passing an approved English language test.

Having an academic qualification taught in English.

Being a citizen of a majority English-speaking country.

Financial Requirement

Maintenance Funds: Applicants may need to demonstrate they have enough personal savings to support themselves on arriving in the UK, usually £1,270, unless their employer can cover this in their Certificate of Sponsorship.

Application Process

Obtain a Job Offer

- Before applying for the visa, the applicant must secure a job offer from a licensed sponsor.

Certificate of Sponsorship (CoS)

The employer must provide a Certificate of Sponsorship, which includes details of the job and confirms sponsorship.

Gather Required Documents

Applicants will need various documents to submit with their application, which may include:

Passport or travel documentation
Proof of knowledge of English
Certificate of Sponsorship reference number
Proof of personal savings (if required)
Previous UK immigration documents (if applicable)

Submit the Application
