Notes:

- Publishers are part of the ORCID ecosystem along with funders, universities, etc.
- Publishers role is to write publications and peer review to authors/reviewers' ORCID records
- Authors need to connect their authenticated ORCID iD with the publication/publisher the author will be prompted to connect/authenticate their ORCID iD during the
 manuscript submission process or during account registration (this ORCID
 authentication happens through a process called OAuth)
- The author can also grant permission for the publisher to update their ORCID data via the OAuth process

- Co-authors can also authenticate their ORCID iD typically through an email process co-author receives an email prompting them to connect their ORCID iD with the publisher/publication
- Authenticated ORCID iDs are then displayed on the publication with the author's name presence of the green ORCID iD icon means that the author connected their authenticated ORCID iD
- Some publishers adds authenticated ORCID iDs in the DOI metadata and these can be pushed to ORCID records via Crossref and DataCite
- Authors, co-authors, and contributors can also use Search and link wizards in ORCID specifically Crossref and DataCite to add their publications to ORCID record
- Peer review activity can be added to ORCID by publishers, if available
- Publishing software platforms with built-in ORCID integrations have different functionalities
- Publishing workflow in OJS:
 - York University has several journals
 - Most active journals have 38 authors total with 18 connecting ORCID iD, and 24 total authors with 20 ORCID iDs connected
 - If you want to use the ORCID plugin for OJS, you need to get your ORCID member API keys, process will vary depending on how many journals, etc. - see documentation: https://docs.pkp.sfu.ca/orcid/en/ - documentation also covers how the plugin works and how to set it up...
- Peer review workflow in OJS:
 - Columbia University one of the first institutions using this, they have several active journals
 - Using peer review functionality in student undergrad journals
 - See ORCID plugin documentation for details on setting up peer review:
 https://docs.pkp.sfu.ca/orcid/en/ city and state information, and ISSN need to be filled out for the journal
 - Once an article has been added to submission queue, you can add reviewers info for that article - use the email template to request review. You can select review type (open or blind), which has an impact on what shows up on the ORCID entry
 - o Reviewers add ORCID iD in their OJS profile
 - o (side note) Columbia will be mandating ORCID for all OJS contributors soon
 - After the review is complete, you can thank you the reviewer, which writes the peer review activity to the ORCID record of the reviewer
 - o Can retrospective reviewer credit be given? Yes, there are some workarounds

- what indicates whether an entry in an orcid record gets a green check?
 - the green check means that the entry was added to the ORCID record by an organization via the ORCID member API, as opposed to the user adding the entry to their own record

- can you go over the crossref notification again? I thought it was automatic once you authenticate through search & link?

- is the 'preferred source' something that can be set at an individual work/item level? Or is there a built in hierarchy?
 - Preferred source can be controlled individually. ORCID will automatically grouped works together if they have the same DOI or common identifiers. You can also group work together manually.
