  - Researched by Cluster Coordinator Nadia check yourn2022 filing. For the 2021 one, the IRS provides this information. Link of approved 990N postcard filers:

  - There may be a fee associated with it. I checked one out and was \$54. But if we don't file, we risk our 501c3 being revoked bc we didnt file for 3 consecutive years.
  - There may be an issue with the fiscal cycle. IRS may have somehow switched us from fiscal to calendar year in their system? We are all supposed to be on a fiscal cycle of July 1 to June 30.
  - This is a direct copy from the [FreeState Financial guide](#): These forms MUST be filed with the IRS by the 15th day of the 5th month after the close of the PTA'S fiscal year (November 15th). A copy of the forms MUST also be sent to Free State PTA by December 15 th annually. The IRS will AUTOMATICALLY REVOKE tax-exempt status when an

exempt organization REQUIRED to file an annual return (e.g., Form 990, electronic 990-EZ, or electronic 990-N e-Postcard) does not do so for three (3) consecutive years. Under the law, the organization's federal tax-exempt status is automatically revoked

6. From 990 needs to be submitted before Nov 15

- Form 990s are due 5 and a half months after the end of an organization's fiscal year.
- PTAs have a June 30 year end, our 990s are due Nov. 15, whether you file the postcard or EZ. You can file for an automatically-granted 6-month extension. I don't recommend doing that unless there are extenuating circumstances. A lot of things can get lost, and memories fade, if you wait to file almost at the end of the next year.
- Some PTA's do use a professional account to (1) do our annual review and (2) prepare our 990 EZ and file it electronically. Our Treasurer does our state filings (Annual Renewal of Registration and Annual Return). We use a local self-employed CPA who used to be a school parent (that's how we found her). She performs a review of our books, but does NOT perform an audit. To an account, those are two very different things. If you are looking for an accountant to do your review, be sure to ask for pricing for a review, not an audit. We spend about \$1,000 for both of those services and that is an annual budget item for us.

This would show whether or not the event is meeting the budget and automatically support any requests for the budget to be increased.

18. First MCCPTA Diversity, Equity & Inclusion Committee meeting Sep 28, 12:00 Zoom

At our first meeting, we'd like to kick off the year with a Town Hall format and offer everyone a chance to let us know what their most critical topics of interest are this year, as you all review the needs of your school communities with respect to diversity, equity and inclusion. We would like to plan our year based on your input.

Here are some other topics that many of you have brought up to us recently:

- How do I go about my role as a DEI representative for my school community?  
What are some of the things I can do to engage widely with our families and staff?  
What is the best way to conduct outreach consistently this year as our school's DEP rep?  
Our school is about to lose our PTA status because we have not been able to turn all of our required paperwork in. Is there anyone within MCCPTA or Free State who can help us retain our membership?  
How can we best role model being inclusive when there are so many fights breaking out in different parts of the community?
- How can we get interpreters to help us include a wider reach of parents, care givers, staff and/or students at our PT(S)A functions?
- We would love to have people share what other topics or activities would be helpful to you and your communities this year.

Our last year focused on many things, not the least of which were: holding collaborative workshops with DEI representatives; collaborating with Black & Brown Coalition; participating in MCPS anti-racism audit workshops; holding a workshop on Sustainability in partnership with the MCCPTA Green Team; participating in workshops on Social Studies curriculum updates with the MCCPTA Curriculum Committee; holding an LGBTQ+ speaker forum; holding a workshop on antisemitism and anti-discrimination strategies with several non-profit and religious community and MCPS leaders; holding a Restorative Justice program with the MCPS RJ team; providing planning and support for the Spanish speaking Family Day at Kennedy High School in partnership with the MCCPTA ESOL committee; and providing testimony on numerous DEI issues at various Board of Education meetings throughout the year. We also formalized our DEI content on the newly revised MCCPTA web site.

Our goals for 2023-2034 academic year include continuing our work with a brand new DEI audit of MCCPTA's structure and outreach and programming to help ensure that all planning and programming activities are conducted with an inclusive and equitable approach for all schools; incorporating DEI training for the DEI representatives and the wider community within MCCPTA in fall and spring workshops; continuing to focus on sharing events, best practices and other opportunities with DEI reps and their schools and clusters; and continuing to work with the MCPS RJ team to amplify awareness within the MCPS community of the need for creating healthy, restorative cultures within our schools. The MCPS anti-racist audit is undergoing a review and we look forward to hearing soon what their approach and next steps will be for this year.

19. Does every student have a calculator?

- There is an app for the graphing calculator on phones. But what about students without phones?
- Yes, the policy is no phones in ES and MS, but teachers are allowed to make exceptions, such as for math class.
  - 1) This should be resolved at the lowest possible level. I'd recommend an inquiry go to the principal (or math RT) expressing concern over lack of calculator availability during these exams and if the principal has a count on how many were denied access.
    - a. If the parents bringing this to your attention have already done this, then it is appropriate to elevate the conversation. But, if this is new information for the principal/RT, then start the advocacy there...
    - b. If this isn't new information, the question is "why" and "what are we going to do about it?" Again, I'd encourage allowing the principal/RT to resolve before elevating to central office.
  - 2) With regard to taking calculators home – I'd encourage you to ask what the practice is for the school with regard to calculators. Once upon a time, the math department at one of the two high schools where my kids have matriculated, used to take "orders" at the beginning of the school year so students could purchase the same

calculator the school used at the same discounted cost as the school. I haven't seen that in a while so not sure if that still happens...

a. The aim of the school should be to have calculators for every student in class... I don't remember (and I'm on my 4<sup>th</sup> high schooler now) there ever being a calculator assigned (like a text book) for them to bring home.

b. HOWEVER, as someone else pointed out, though it isn't a practice to assign a calculator to every student for "at home use" – it wouldn't surprise me at all if there is a mechanism for just such an activity where there is need expressed. Before covid and chromebooks were assigned to every student, our high school (through the media center) did assign chromebooks to ~200 to kids to ensure they had computer access at home. It wouldn't surprise me if there is a similar activity related to calculators. And, those students must return at the end of the school year with text books.

3) In terms of budgets to pay for these calculators -- the principal receives an allocation each year to purchase text books, supplies, etc. If the school doesn't have enough calculators for all students in these classes, this conversation should spur the intention to purchase more through this mechanism for next year.

4) There may be instances where a PTSA would be asked to purchase something like this but it is incumbent on the principal to ensure PTSA funds are not being used for purposes already allocated (and having calculators in the classrooms seems to be a necessary "tool" for these classes and should be included in the course supply list).

23. Update on Literacy numbers for MCPS from MCCPTA Curriculum Committee

- MCPS just reported to the Board of Education the baseline results of the third grade MAP-R. They are baseline because most of this group of third graders has not benefitted from the countywide rollout of Really Great Reading that started last year. (Unless they were in a pilot school). I attached the results - you can see there was

less than 60 percent proficiency across all groups, and lower rates for Black and Hispanic students than other groups.

- In short, we have been supporting MCPS's shift to Structured Literacy but asked for school level data so we can see how well each school is doing. Then we asked MCPS to finish the job by choosing and implementing a stronger K-5 curriculum. This is something we have been advocating for in the last year directly with MCPS through our terrific Elementary ELA Lead Regan Kelly.
- Strong literacy curriculum and instruction - not just in elementary but in middle and high school too - benefits everyone. The podcast Sold a Story is an interesting one for your car ride - it talks about how many school districts - including Montgomery County - weren't following the science when teaching reading. One MCPS teacher said she assumed there were no issues in an affluent school, but the truth is that affluent parents were getting tutors and supplementing.
- If we see systemic disparities, that often is a sign of broader issues that affect all of our children. I am really excited about and fully support the work the Black and Brown Coalition is doing to raise awareness of these issues.

The ECCC monitors, advocates, and makes policy recommendations for the development of a comprehensive system of early care and education (ECE) in Montgomery County that supports children entering school ready to learn.
- Who is on the ECC: The ECCC is comprised of a variety of stakeholders and professionals with expertise in the early childhood field including County parents, business and foundation representatives, child care providers, local ECE associations' representatives, a pediatric representative, Montgomery County Public Schools (MCPS) staff, Maryland State Department of Education (MSDE) staff, Montgomery County Libraries and County Government representatives. Our collective knowledge and expertise about ECE, the importance of school readiness, and the needs of children and families in Montgomery County allows the ECCC to examine, discuss, problem solve, and provide a comprehensive perspective about early care and education to County officials.

- However, the ECC is undergoing changes because of the recent creation of the Children's Opportunity Alliance. As a result, the ECC is currently on hiatus. Nevertheless, since our current ECC representative's term ends in October, we want to ensure that we have a replacement selected before her term ends, and to ensure a smooth transition/handover.

#### 25. Bridge program for IEP students

- Bridge. The MCPS web site describes the program as designed to meet the needs of middle and HS students who may have social emotional challenges that impact their ability to meet the general education curriculum. These challenges may include: emotional social vulnerability, problem solving, abstract thinking, organizing and

planning, interpreting social cues, establishing relationships with peers, coping with anxiety, sensory sensitivity, pragmatic language and attention. It appears to be an excellent program and extremely helpful for many families.

- Best Buddies which pairs neurotypical peers with students with IEP's to meet once a month at school and do occasional activities out of school. All those programs were run and/or coached by LFI/SCB teachers and paras. Damascus HS lucky to have staff that volunteered their time to support these programs and also parents that volunteered to help as well.
- We can't force/require paras to support without being paid. We have always been lucky in our programs in the DHS cluster but I know as a parent of an adult with intensive special needs that this wasn't the norm. MCPS has a great allied sports program in high school but many schools don't participate for lack of support. That in my experience has correlated to lack of parent support as well.
- There are students that attend with respite providers and personal aides. That is the only real solution I see currently. The burden to provide them falls on the families of students or the parents can attend and facilitate the extra personalized attention the student requires.
- There are also a ton of non MCPS opportunities for special needs students like MoCo Movement, Zam Dance, Autism Ambassadors social group, SOMD, Miracle League in Germantown and the DSA Challengers to name a few.

The MCPS Operating budget historically, significantly underfunds arts classes (instrumental music, visual arts, chorus, dance, ceramics, theatre). These curriculum based classes require budgets for instrument sales and purchases, stage sets, music licensing, transportation to juried festivals, arts materials such as paint, brushes, canvases, clay, dark room supplies, etc. Arts warrant the same attention as our other terrific classes (and are included in diploma requirements). Our creative students deserve programming support to participate in a fully robust educational setting. Generally, the arts programs are funded 50% of what is required (which leads to an inconsistent hodge podge across the county, often resulting in inequitable circumstances).

- Use it to create a mail merge with the free Google Utility "Form Mule". Find a YouTube video on how to use it.
- You need the excel in google sheet. It must be created in google so that it's a .docx file.
- Then in the spreadsheet, go to Extension and find Form Mule. Install the Utility if its not there.
- You cannot do a mail merge on a set of rows from the spreadsheet, it has to be the entire row. Groups have to be created in separate tabs.
- Do a test and send one email so you can make sure it's formatted correctly.
- Spreadsheet must have a header for each column and there cannot be blank rows
- **Elected officials do not like form emails, so create your own version of the email and then use the Form Mule to send out the personalized email to your representatives.**
