

## New MAT Graduate Student Checklist 2025-2026

### APRIL - MAY

- ☐ Complete your Statement of Legal Residence ([SLR](#))
- ☐ Activate your [UCInetID](https://www.reg.uci.edu/stlr/Welcome.do) <https://www.reg.uci.edu/stlr/Welcome.do>
- ☐ Look for an email or check the New MAT Student Website for information about Summer Aid - date TBD
- ☐ Complete the placement survey (on [New MAT Student Website](#)) with the MS or SS coordinator and sign up for a Zoom meeting.
- ☐ Attend the virtual MAT Financial Aid Information Session- date TBD
- ☐ Submit Free Application for Federal Student Aid ([FAFSA](#))
  - ☐ *MAT students need to file 2024-2025 FAFSA for Summer 2025 Financial Aid and 2025-2026 FAFSA for receiving Financial Aid through Summer 2026. An additional Summer Financial Aid Application is also required and a link to this form will be provided later.*
- ☐ Look for email notifying you about automatic enrollment in Summer Session courses
- ☐ Waive Summer Graduate Student Health Insurance Plan (May 19th-June 2nd 2025)  
*\*Please wait until specific instructions for waiving health insurance are posted on the New MAT Student Website*

### JUNE

- ☐ June 1: Deadline for TB test results: You will receive instructions on how to upload immunizations and TB records to the UCI Student Health Center student portal. All MAT candidates must provide a negative TB test result dated on or after January 1<sup>st</sup>, 2025. Negative TB test results dated before January 1<sup>st</sup>, 2025 will not be accepted. There will be a \$20 charge from the UCI Student Health Center to conduct this mandatory review.
- ☐ June 12th (Non-CSET completers only): Sign and return *CSET Policy Acknowledgement* document to coordinators or defer enrollment until 2026-2027. (Coordinators will send this out)
- ☐ June 21st: Summer Session tuition deadline
- ☐ June 20th: Participate in orientation on campus 9:00-3:00
- ☐ June 23rd: Summer Session 1 begins (all classes held on campus)

### JULY-AUGUST

- ☐ Fall 2025 schedule e-mailed to students by 7/31: *E-mailed schedule will include additional details not available on WebSOC (Web Schedule Of Classes).*
- ☐ Mid-July watch for an email from Student Affairs with a link to a prerecorded enrollment video on how to enroll in fall courses through [WebReg](#)
- ☐ August 4th: Summer Session 2 begins (all classes held on campus)
- ☐ August 5th: CSET deadline
- ☐ Early August-Early September: Fieldwork begins (start date depends on district calendars)
- ☐ Clear Provisional Admission by providing official degree-posted transcripts from your university
- ☐ *\*Degree-posted transcripts should be mailed directly to Graduate Division, 120 Aldrich Hall Irvine, CA 92697-3180. Official e-transcripts can be emailed to [gradtranscripts@uci.edu](mailto:gradtranscripts@uci.edu)*
- ☐ Waive Graduate Student Health Insurance Plan ([GSHIP](#)) if you have comparable health insurance
- ☐ *\*This needs to be done again, even if you already waived out for summer*
- ☐ Pay Fall [tuition](#) through your ZotAccount, in person, or through mail
  - ☐ Tuition must be paid on or before the fee payment deadline, October 17th, to avoid being dropped from courses.
  - ☐ Quarterly deadlines can be found on the Registrar's [Academic Calendar](#)

**SEPTEMBER- DECEMBER**

- ☐ September 23: last day to defer
- ☐ Scholarships are deposited to students' Zot account during week 6 of fall quarter (please enable direct deposit)
- ☐ Loan forgiveness programs such as GSTG may not fund until late December-January
- ☐ Residency stipends are awarded in late December or as scheduled by the District

- ☐ Pay Fall [tuition](#) through your ZotAccount, in person, or through mail
