

# Mobile App Privacy Policy

## Introduction

Thessai Corporation ("**Company**" or "**We**") respect your privacy and are committed to protecting it through our compliance with this policy. This policy describes:

- The types of information we may collect or that you may provide when you [purchase,][download,][install,][create an account on,] access, or use the Thessai Application (the "**App**").
- Our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies only to information we collect in this App [./and] in email, text, and other electronic communications sent through [or in connection with ]this App] [, and [ANY OTHER SOURCES]].

This policy DOES NOT apply to information that:

- We collect offline or on any other Company apps or websites, including websites you may access through this App.
- You provide to or is collected by any third party, including other apps, websites, or content that may link to or be accessible from or through this App (see **Third-Party Information Collection**).
- [OTHER SOURCES].

Our websites and apps, and these other third parties [may] have their own privacy policies, which we encourage you to read before providing information on or through them.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, do not download, create an account, or use this App. By downloading, creating an account, or using this App, you agree to this privacy policy. This policy may change from time to time (see **Changes to Our Privacy Policy**). Your continued use of this App after we revise this policy means you accept those changes, so please check the policy periodically for updates.

## Children Under the Age of [13/16]

The App is not intended for children under [13/16] years of age. No one under age [13/16] may provide any [personal] information from children under [13/16]. We do not knowingly collect personal information from children under [13/16]. If you are under [13/16], do not use or provide any information on this App [or] [through any of its features,] [create an account on the App,] [make any purchases through the Website,] [use any of the interactive or public comment features of this Website,] [or provide any information about yourself to us, including your name, address, telephone number, email address, or any screen name or user name you may use]. If we learn we have collected or received personal information from a child under [13/16] without verification of parental consent, we will delete that information. If you believe we might have

any information from or about a child under [13/16], please contact us at [CONTACT INFORMATION].

### Information We Collect and How We Collect It

We collect information from and about users of our App:

- Directly from you when you provide it to us.
- Automatically when you use the App.
- [OTHER COLLECTION METHODS.]

### *Information You Provide to Us*

When you download, create an account, or use this App, we may ask you provide information:

- By which you may be personally identified, such as name, postal address, email address, telephone number, [ Social Security number,] or [[ANY OTHER INFORMATION THE APP COLLECTS THAT IS DEFINED AS PERSONAL OR PERSONALLY IDENTIFIABLE INFORMATION UNDER AN APPLICABLE LAW]/any other identifier by which you may be contacted online or offline] ("**personal information**").
- That is about you but individually does not identify you, such as [TYPES OF INFORMATION].

This information includes:

- Information that you provide by filling in forms in the App. This includes information provided at the time of [creating an account on the App/] [./and] [subscribing to our service] [./and] [posting material] [, and] [requesting further services]. We may also ask you for information [when you enter a contest or promotion sponsored by us, and] when you report a problem with the App.
- Records and copies of your correspondence (including email addresses and phone numbers), if you contact us.
- [Your responses to surveys that we might ask you to complete for research purposes.]
- [Details of transactions you carry out through the App and of the fulfillment of your orders. You may be required to provide financial information before placing an order through the App.]
- [Your search queries on the App.]
- [OTHER TYPES OF INFORMATION THE USER PROVIDES].

You may also provide information for publication or display ("**Posted**") on public areas of the app [or websites you access through the App/www.thessai.com] (collectively, "**User Contributions**"). Your User Contributions are Posted and transmitted to others at your own risk. [Although you may set certain privacy settings for such information by [logging into your

account profile/[PRIVACY SETTINGS INSTRUCTIONS]], please be aware that no security measures are perfect or impenetrable.] Additionally, we cannot control the actions of third parties with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

### *Information We Collect Through Automatic Data Collection Technologies*

As you navigate through and interact with our App, including when you download, access, or use the App, we may use automatic data collection technologies to collect certain information about your device and your browsing and usage activity and patterns, including:

- **Usage Details.** When you access and use the App, we may automatically collect certain details of your access to and use of the App, including [traffic data,] [location data,] [logs,] [and other] communication data and the resources that you access and use on or through the App.
- **Device Information.** We may collect information about your mobile device and internet connection, including the device's unique device identifier, [IP address,] operating system, browser type, mobile network information, and the device's telephone number.
- **Stored Information and Files.** The App also may access metadata and other information associated with other files stored on your device. This may include, for example, photographs, audio and video clips, personal contacts, and address book information.
- **Location Information.** This App [collects] real-time information about the location of your device. [DESCRIPTION OF LOCATION INFORMATION COLLECTION].

If you do not want us to collect this information [do not download the App or delete it from your device/you may opt out at any time by [OPT-OUT METHOD]]. [We also may use these technologies to collect information about your activities over time and across third-party websites, apps, or other online services (behavioral tracking). The technologies we use for automatic information collection may include:

- **Cookies (or mobile cookies).** A cookie is a small file placed on your smartphone. It may be possible to refuse to accept mobile cookies by activating the appropriate setting on your smartphone. However, if you select this setting you may be unable to access certain parts of our App.
- **[Web Beacons.** Pages of the App [and our emails] may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages [or opened an email] and for other related app statistics (for example, recording the popularity of certain app content and verifying system and server integrity).]

[We do not collect personal information automatically, but we may tie non-personal information collected automatically to personal information about you that we collect from other sources or that you provide to us.]]

### *Third-Party Information Collection*

When you use the App or its content, certain third parties may use automatic information collection technologies to collect information about you or your device. These third parties [may] include:

- [Advertisers, ad networks, and ad servers.]
- [Analytics companies.]
- [Your mobile device manufacturer.]
- [Your mobile service provider.]
- [OTHERS.]

We do not control these third parties' tracking technologies or how they may be used. ### How We Use Your Information

We use information that we collect about you or that you provide to us, including any personal information, to:

- Provide you with the App and its contents, and any other information, products, or services that you request from us.
- Fulfill any other purpose for which you provide it.
- [Give you notices about your [account/subscription], including expiration and renewal notices.]
- Carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.
- Notify you when App updates are available, and of changes to any products or services we offer or provide though it.

- [OTHER USES.]

The usage information we collect helps us to improve our App and to deliver a better and more personalized experience by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our App according to your individual interests.
- Speed up your searches.
- Recognize you when you use the App.

[We use location information we collect to know the motion and location of the person being monitored.]

[We may also use your information to contact you about [our own and third parties'] goods and services that may be of interest to you. [We may use the information we collect to display advertisements to our advertisers' target audiences. ### Disclosure of Your Information

We may disclose aggregated information about our users[, and information that does not identify any individual [or device],] without restriction.

In addition, we may disclose personal information that we collect or you provide:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business[ and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them].
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Thessai Corporation's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Thessai Corporation about our App users is among the assets transferred.
- [To third parties to market their products or services to you if you have [consented to/not opted out of] these disclosures. - To fulfill the purpose for which you provide it. [For example, if you give us an email address to use the "email a friend" feature of our App, we will transmit the contents of that email and your email address to the recipients.]
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your personal information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce our rights arising from any contracts entered into between you and us, including the [App End User License Agreement/Terms of Service [END USER LICENSE AGREEMENT OR TERMS OF SERVICE.](#)] and for billing and collection.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Thessai Corporation, our customers, or others. [This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.]

### Choices About How We Use and Disclose Your Information

We strive to provide you with choices regarding the personal information you provide to us. This section describes mechanisms we provide for you to control certain uses and disclosures of over your information.

- **Tracking Technologies.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted through our App. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures included through the App.]
