TRIGGER WARNINGS: DRAWING OF CENSORED ZOOPHILIA, BOTH FICTIONAL AND REAL INCEST, INTENTIONAL TRANSPHOBIA, MENTIONS OF SCAT/PISS, PEDOPHILIA, SELF HARM, TALK/IMAGES OF SEXUAL CONTENT, TALK OF SEXUAL ASSAULT/RAPE, AND GROOMING. PROCEED WITH CAUTION.

To begin, this doc is purely about Jake, AKA opencessarial jake on youtube. I will not let bias seep into this and only use objectively correct statements. When I say that Jake is a pedophile, I am not saying it lightly. He has stated he likes the idea of dating somebody younger than him so that he can take advantage of them, particularly younger girls. Everything I say will be backed up with evidence, or at the very least a statement behind it. Whether you choose to believe anything stated here or not is up to you, but Jake still has an actively large profile where he still receives interactions from children in his replies to this day. This doc has been made due to the fact I worry he has the potential to find new victims and continue grooming Anon X.

I am going to refer to myself as **Anon B** (Minor), and there are going to be multiple other anons referenced throughout. Here is a brief explanation of each and what part they play in this, most screenshots will be color coded (ones that aren't are from Anon S censoring them instead of B):

Anon X: (17) Current close friend of Jake's (also one of his victims), ex-friend of Anon B and Anon R.

Anon W: (Minor) Helped me get evidence by pretending to be **15**. Became 'friends' with Jake to get more evidence/screenshots.

Anon One: (15) Victim

Anon Two: (Unknown, presumed minor) Claimed to be 13-14 to Jake, victim

Anon R: (Minor) Ex-friend of Anon X

Anon N: (15) Victim

Anon Four: (15) Jake thought they were **13**, victim

Anon S, Anon F, Anon G, Anon W: proofreading, censoring screenshots, helping in general

ANYBODY WE DO NOT KNOW THE IDENTITY OF/IS MENTIONED AS A ONE-OFF IS JUST GOING TO BE LEFT BLANK.

There is some important context here as to where these screenshots are from as well, so here's the key for determining that:

- Images from the group chat that Jake referred to as his "work gc" will be labeled with **-gc** at the end. The people in this group chat were *Anon One, Two, X,* and at one point *Anon W* for a small moment in time. There were others in there too (according to Anon One), but it's unknown who they are or if they were victims or not. These screenshots are from both Anon W and me (B) screenshotting what we saw. I got into the group chat from a link sent to W from Jake.
- Images from discord in general won't be marked unless they're from the before mentioned GC.
- Images from youtube will be marked -yt.

Also, because I'm not entirely sure where to put this but I know someone will say something, I don't believe Jake finding fictional incest/zoophilia attractive is at all comparable to anything else he has done in this document. The only reason I've included it in this is because he sent it to a minor and it's presumed a minor made it. No matter your stance on fictional material, it can be agreed that Jake should not be sending porn to minors or asking minors to create it.

The only accounts affiliated with this document are @ImLegitOnFireOw on twitter and tiktok. I don't want people spreading misinformation. Remember these anons will always be anonymous and their identities will not be revealed for any reason; this includes the people who created the doc to begin with. Currently the Anons running this account are B and F.


ANON ONE + TWO

ANON ONE AND TWO'S EXPERIENCES WITH JAKE


Anon One (15) and Two (Unknown, probably minor) are going to be first in this document because of the massive amount of direct evidence of Jake admitting to everything he's interested in and what he has done.

Also, this is not 100% confirmed, but Anon Two was apparently doing something similar to W in the way that they were interacting with Jake in an attempt to fish for evidence. *Jake still thought that they were 13-14*, their real age being unknown even to me. Transphobia, incest, sexual content, and drawn zoophilia is mentioned here.



At this point, Anon X still had their pronouns as he/it on their discord profile, which is why Anon One was confused as to what to refer to X as. I (Anon B) understand my language here can be seen as odd but I was trying to make it crystal clear why Jake was doing what he was doing.





^ Jake asking repeatedly for the "underwear of the day," assumedly either pictures or descriptions of what underwear Anon One is wearing.




^ Jake detailing his incestuous thoughts he has about his sister and how he would hate to "touch her underwear and ruin it," implying he's done something like this before.



^ Although I don't have the context for this screenshot, Jake talks about how he finds groping attractive to Anon One and how One's doodles are "sexually pleasing" to him.




^ Jake discussing his piss fetish to One.




^ Jake sending zoophilia porn to One.




^ Jake telling One he "loves them" because they have nice art, they're young, and he likes talking to them.



^ Jake discussing how he wants to have sex with Anon One.




^ Jake sending his "secret youtube channel" to One to escape from the "hate" of his last allegations.








^ Jake implying that One should be incestuous with their brother.



[^] Talking about how he likes incest to One.






^ Proof of this being Jake's account. The email shown in the screenshots is the same as the one listed on his youtube profile with all his socials.

ANON X


ANON X, MY EXPERIENCES AND ANON R'S EXPERIENCES WITH THEM, AND THEIR EXPERIENCES WITH JAKE

Anon X, someone who used to be a close friend of mine for around two years, is currently in a close (known to at least previously be sexual) relationship with Jake. It is unknown if this relationship is romantic or not, so I will just be referring to it as a "close friendship." Originally, this Anon was going to be first, but I decided that Anon One's evidence would provide context to what is said in this section.


Some important context as to how I will be referring to Anon X pronoun-wise is that for the entire time me and X were friends they identified as a trans man. They typically strictly used he/it or he/they and never used she/her. Though, now, on their discord profile's pronouns section it says "she/her," so I will refer to X This is where the transphobia warning comes in again, because it can be assumed that Jake purposefully misgenders X to view them as a girl because that's simply what Jake is attracted to.




[^] Older screenshot, around March-April 2025. Shown is Jake linking to their (1, 2, x)s' youtube profiles and calling them his 'slaves.'



^ Jake referring to his coworkers/the minors as "slaves".




^ Anon X admitting to thinking they're letting themselves "be groomed." This is contrary to the stance they have now on things, claiming that they know they aren't being groomed and that they know Jake is changing as a person.



^ Anon X telling me everything Jake has asked them to do. In summary: X details how Jake asked them to draw nsfw of Jake's sona and their own sona, how X thought Jake would change, and how Jake asked for pictures of X wearing just their underwear, and how Jake offered X a place to stay. X is 17 years old at this point in time and Jake is 19.


Jake asked this 17 year old to <u>live with him</u>. For context, X's current place of living is not a healthy environment for them and Jake is trying to take advantage of that.




^ Jake discussing his sexual thoughts to the group chat containing only minors. X expresses enthusiasm with the change of the group chat name. -gc






^ Jake greeting the group chat (with a 17 year old, 15, and suspected 13 year old in it) and X responds. -gc




[^] X claiming Jake "likes children," albeit in a joking manner.





"Smookie" is also not a person's name, just a nickname Anon R gives their friends occasionally. In the second message Anon R is referring to me (B) because I was currently upset that Anon X had lied to me.




[^] Anon X detailing everything Jake has done for them. X clearly views these as positive things but it shows the unhealthy dynamic of Jake being their boss and, again, offering them a place to live.




^ X says "it's almost like [they] want it" or "deserve it," referring to Jake's grooming.




^ I feel this is important to include because it shows how X currently feels about the situation. They think they're helping Jake get better and that everything Jake has done


to them is 'normal', despite all of this being false.



^ Me confronting X about the youtube post part 2. The lying is in referral to them telling me they left Jake previously, which this post confirms was a lie. I allowed them one more chance after this to actually block Jake and move on, but unfortunately they never did. I realize now that I should've stopped at this point as X defending Jake publicly should've been my breaking point.




^ X telling Anon B what Jake has sent them. "Voice stuff" refers to audio of him "moaning [x's] name."




^ 7/24/25, Anon One confronting X about how they are still close friends with Jake. One details how Jake referred to them as his "pets." X also says that Jake "loves them."



^ Takes place right after the screenshot before. Again, X brings up how Jake has offered them a place to stay, even 2 months later from when he last offered. In the screenshot One sends, Jake says "[his] other pet just [asked him] to be her girlfriend." At this point in time, we aren't sure if this person is Anon X or somebody else. Also, I refer to the sexual status, which could possibly be something Jake said, though I have no evidence for this.



^ Recent animation meme of Jake's sona. The beginning shows Anon X's sona kissing Jake's on the cheek.




^ 8/23/2025, this is what it currently says when you check Jake's profile, showing that Anon X is still friends with him. A reminder to please not seek anybody here out.


ANON W

ANON W'S EXPERIENCE WITH JAKE


To be *completely clear* about every piece of evidence listed, it is true that this situation was staged in the way Anon W lied about how old they were in order to get closer to Jake. Anon W *is* still a minor though. W went into this situation to see if Jake was actually trying to change, but when Jake started flirting with them (seen in screenshot below), W knew Jake wasn't trying to change whatsoever. Jake never knew how old W actually was, only that W was supposedly "15." These facts though do not remove from the legitimacy that Jake was attempting to groom another minor. There will be a censored photo of Jake's genitalia and talk of sexual content in this section, do not proceed if you are uncomfortable with that.




^ Anon W explaining motives to begin conversing with Jake.




^ Telling someone he thought was a *15 year old* to masturbate to the thought of him. Also shown is evidence of this being Jake's account.




^ Shows proof that this is Jake's account, his nude image can be seen in the background. The "save it quick" implies he's going to delete it. The censor was added in post.

^ Jake trying to form a connection and get W closer to him by taking advantage of their insecurities.






Anon N, next to Anon Two is the least anon I know about. Anon One was the one to send me all of the evidence for these screenshots and I wasn't able to receive much context. These screenshots also seem to start around March but I figured they were still important to share. WARNING for mentions of rape and sexual roleplay.

^ Jake asking if N wants to perform sexual favors for him, then encourages N to draw more NSFW art. He also brings up his piss fetish again.



[^] Drawing by assumedly N is not sexual in any way, but again, censored to protect their anonymity. Jake again expresses how this drawing made him sexually aroused.





CONCLUSION/EVIDENCE TO TIE EVERYTHING TOGETHER

CONCLUSION

Thank you for getting this far. We are aware that Jake has had previous run-ins with controversy previously, such as grooming allegations. We thought that this doc was necessary to create and put out there because Jake still has an active platform and still seeks out more minors to take advantage of. His community posts where he is the most active receive a minimum of 1,000 likes each and his animations still receive roughly 130k views each. I see people in his replies defending him, claiming that he *is* trying to change, when we all know that isn't true. I could no longer stand here and allow what I knew to stay under the radar. Even the small community that Jake has now is still far too large.

We know that Jake has pictures of minors in their underwear, we know he's sent them sexually explicit images of himself, it's suspected he spreads these images around to his coworkers, we know he finds his own sibling attractive, and we know he's an active predator. To let him get away with this would be sickening. Spreading this document wherever you can would be extremely helpful, but as a reminder, **DO NOT HARASS ANYBODY MENTIONED HERE, EVEN JAKE.** Jake is a terrible human being that I think deserves only the worst, but to go to him yourself and try and get a rise out of him would be stupid, especially considering a large majority of people in this community are minors and I don't want more people endangering themselves. Please, do not seek any of the anons mentioned here out, as it would put them in more danger. What I do encourage though is informing people. If you see somebody claim that he has changed or is seeking help, politely send them this document and ask them to read it.

I greatly, GREATLY appreciate the <u>youtube video by Juki</u> that was created to spread awareness and I greatly appreciate whoever informed this creator of the situation at hand. Though I have already seen people harassing Jake in his replies, and I have to repeat myself, please be careful. Do not trust Jake to be around any of yourselves, especially if you're a minor.

If you or anybody you know has been affected by Jake and would like personal help or for your story to be added to this document, please reach out to me (Anon B) through dms on Twitter. The dms are open to everybody as of now. This includes Anon X, though they know how to contact me if they want to.
