1. Information on AEGEE-Dresden e.V.'s processing of personal data as part of the buddy program.

Your data will be processed and stored on behalf of AEGEE-Dresden e.V. In order for AEGEE-Dresden to use your information to fulfill its duties regarding the services offered to you during the buddy program, you must agree to a consent form. This form must be either submitted in digital form (i.e. Google forms), or printed, signed by you, and then handed out to a member of AEGEE-Dresden.

The personal data you submit may be used in digital form, in various channels used by AEGEE-Dresden to offer the buddy program services. This includes but is not limited to :

- First-party mailing lists hosted at the aegee.org domain name, which are used to broadcast newsletters, and updates to all participants of the buddy program.
- Second-party individuals (i.e. buddies), who are direct participants of the buddy program, and consumers of our services.
- Third-party services such as Google drive, which are used by AEGEE-Dresden to collect, store, and process your information.

The information you submit will be used for a maximum of 7 years. The data may be stored in the AEGEE-Dresden's data bank, which is available to its members. At the moment, AEGEE-Dresden uses Google Drive, and Google Forms to retain and collect the aforementioned personal information. Most data used by AEGEE-Dresden will be archived for the future when no longer in use, in accordance with the European General Data Protection Regulation (GDPR).

AEGEE-Dresden is neither responsible nor accountable for privacy or security violations to your data caused by other entities (e.g. Google, Listserv). You are thusly encouraged to follow-up on their corresponding data privacy & security policies.

If you want to know how your personal data is used, or you feel that we have used your personal data in a way that violates the agreement or current legislation, please contact the AEGEE-Dresden Buddy program responsible.

If you have complaints regarding AEGEE-Dresden's processing of your personal data, you are always entitled to contact the relevant inspection authority, the German Data Protection Authority.
