Tax credits are a wonderful way to direct your tax dollars to our Gilbert Tiger Baseball program and it will COST YOU NOTHING! (see below explanations) You can determine where your tax dollars go, so why not help out our SELF-FUNDED Gilbert Tiger Baseball program by directing your tax dollars to a worthy cause.

You can direct your tax credit in one of three ways. For the first two listed, you can donate online at <https://www.gilbertschools.net/taxcredit>. The third way is to manually complete the printed form.

- 1) Complete online under **PARENT DONATION** – Infinite Campus required.
 - a. Log into Infinite Campus - Click on Make a payment “In Touch” - Click Players Name
 - b. Enter – GILBERT BASEBALL TAX CREDIT in SEARCH BAR
 - c. Then follow Buying instructions
- 2) Complete online under **COMMUNITY DONATION** (EASIEST of 2 online options).
 - a. Enter – Gilbert High School
 - b. Enter – Tax Credit Baseball
 - c. Enter – STUDENT/PLAYERS Name and Dollar Amount
 - d. Complete Credit Card information
- 3) Manually Complete **SECONDARY TAX CREDIT FORM**
 - a. Complete Taxpayers info including email
 - b. Enter Dollar Amount
 - c. Enter Students Name
 - d. Parent/Player only: Check box if you want \$100 going toward your student ATHLETIC fee, otherwise leave blank
 - e. Enter Dollar Amount under BASEBALL #11702
 - f. **CHECKS PAYABLE TO: GILBERT PUBLIC SCHOOLS**
 - g. Deliver Tax Credit Form and check to the Athletic Department at Gilbert High School or mail to Gilbert Public Schools, Business Services, 140 S. Gilbert Rd, Gilbert 85296. If you deliver to High School or District please email the Booster Board (gilberttigersbaseball@gmail.com) so we make sure the funds make it to Gilbert Tiger Baseball.

***Individual tax payer can donate up to \$200 and joint tax payers can donate up to \$400.

HOW IT WORKS: You cut a check right now to Gilbert Public Schools, then when you file your ARIZONA STATE(State Only) tax return you can claim the credit on form 322. As long as you paid taxes into the state, you will get a dollar for dollar reduction on tax liability. So, let's say you paid \$2000 in Arizona state taxes and you normally get a refund of \$600. If you donated \$400 to Gilbert Public Schools, your refund would now be \$1000(\$600+\$400). You will get your \$400 back that you paid to tax credit in the refund. By chance you would owe the state money, the amount you owe the state would go down by \$400.
