

8. <u>Litigation Skills Virtual Programs</u>

- (b) Proposed Initial Program Description:

Title: "Practical Tips for the Corporate / Rule 30(b)(6) Depositions in Construction Cases." Goals include discussing and providing practical guidance on:

- 1. Strategic use of corporate depositions and when to take them.
- 2. Techniques to identify designees, object to topics, and timing of disclosure of designees (assuming multiple topics and witnesses).
- 3. Preparation of designees and ethical considerations.

- (c) SPEC (Special Programs and Education) George Fink reported about the February Construction Law Virtual Conference and September 2021 regionals in-person. He reported the CLE group is aiming for 1 CLE per month in 2021.
- (d) Diversity Jessica Sabbath was unable to attend.
- (e) Publications Mike Lane was unable to attend. Tom reported that the Associate Editor positions for The Construction Lawyer and Under Construction will be posted soon. Tom encouraged attendees to apply for the position and described the selection process as it has been done in the past. There was a discussion about the Construction Trial Deskbook and Tony provided the status of the same.
- (f) Marketing MJ Torres-Martin explained the promotion of the supercharged PPT and program. She said that she is on the ENR committee and that an article may be on large construction projects in the southeast. As she learns more, MJ will be in touch with Tom and D1 about any writing opportunities. MJ described the new "I am the Forum" initiative. The idea is to have 60-90 second zoom videos of Forum members about what the Forum means to them. They will start with 16 volunteers. MJ further described collaboration with NAWIC as mentioned above.
