Appeal for the Inclusion of Aquatic Animal Welfare in the Animal Welfare Bill and Live Animal Transportation Standards of Nepal

Respected Sir/Madam,

We, the undersigned members of the <u>Aquatic Animal Alliance (AAA)</u>, extend our appreciation to the Government of Nepal for taking progressive steps by drafting the Animal Welfare Bill and revising the Live Animal Transportation Standards. These initiatives represent important milestones in advancing animal welfare in the country.

Nepal has witnessed rapid growth in aquaculture, with fish farming increasingly promoted as a source of food security and livelihoods. However, despite this expansion, there are currently no policies in Nepal that specifically address the welfare of aquatic animals. Fish are sentient beings capable of experiencing pain, stress, and suffering, yet their welfare remains neglected.

At present, fish are commonly transported from farms to markets in small buckets or boxes, often without sufficient water quality management, oxygen supply, or stocking density control. These practices cause significant distress and compromise both animal welfare and the sustainability of aquaculture systems.

It is also important to note that poor aquatic animal welfare can create wider risks for society. Inadequate welfare standards increase the likelihood of disease outbreaks, which not only threaten fish health but can also lead to serious public health risks and undermine food safety. Furthermore, harmful farming and transport practices contribute to negative environmental impacts, such as water pollution and ecosystem degradation. By adopting stronger welfare standards, Nepal can mitigate these risks and promote healthier, more sustainable aquaculture practices.

The **Aquatic Animal Alliance**, a global coalition of advocacy organizations dedicated to improving the welfare of aquatic animals worldwide through industry engagement, policy advocacy, public education, and scientific research, therefore respectfully urges the Government of Nepal to:

- 1. **Include aquatic animal welfare in the forthcoming Animal Welfare Bill**, ensuring that fish and other aquatic species are explicitly recognized as sentient animals deserving protection.
- 2. Incorporate specific standards for fish welfare in the amended Live Animal Transportation Standards, addressing humane handling, stocking density, water quality, and transport conditions to reduce unnecessary suffering, protect public health, and limit environmental damage.

By including aquatic animals in these legislative frameworks, Nepal can take a leadership role in the region, align with emerging global welfare standards, and support the growth of a more ethical, sustainable, and health-conscious aquaculture sector.

We sincerely hope that the Ministry of Agriculture and Livestock Development and the Department of Livestock Services will consider this appeal and take the necessary steps to ensure that fish and other aquatic animals are not overlooked in this important reform process.
