**CONSENT FOR DISTRICT AUTHORIZED STUDENT TRAVEL
RELEASE, WAIVER, AND INDEMNIFICATION**

I/we, the undersigned parents/guardians of _____ (hereinafter “my Student”), hereby give our consent and permission for Student to participate in and attend a student travel program (hereinafter the “Trip”), which shall occur on September 20th, 2017 through September 22rd, 2017. I/we understand that the Trip is a voluntary activity not required as part of any course of study, and that, but for my/our execution of this CONSENT FOR STUDENT TRAVEL and RELEASE, WAIVER, AND INDEMNIFICATION, my Student would not be allowed to participate in the Trip.

I/we further understand that certain rules of conduct have been established for all participants during the Trip and that I/we assume responsibility for my Student’s actions during the Trip and my Student’s compliance with the rules.

1. I/we assume all liability for and agree to save, indemnify, defend, and hold Littleton Public Schools, its agents, servants, and employees (hereinafter “the District”), harmless from any and all claims or demands of any sort or nature for damage or injury to persons or property caused by the acts or neglect of my Student; and
2. In the event of repeated violations or a serious violation of the established rules by my Student, I/we will accept a collect telephone call concerning my Student’s actions and behavior, and I/we further understand, agree, and consent to my Student being returned home immediately by public transportation at my/our expense, including travel costs for a chaperone to accompany my child.

I/we further understand and agree that my Student may, during part or all of the trip, travel by private vehicle, and I/we hereby consent thereto and specifically (1) waive any and all claims of any sort or nature that I/we may have against the owner and/or driver of any such private transportation for any personal, emotional, psychological, and/or bodily injury or death, and for any property damage regardless of the cause thereof, and (2) agree to hold harmless and indemnify the owner and/or driver of any such private transportation from any and all claims or demands of any sort or nature which may be asserted by or on behalf of my Student for any

personal, emotional, psychological, and/or bodily injury, death, or property damage, regardless of the cause thereof.

I/we understand and agree that the District does not assume any liability for loss or damage to any personal property owned by my Student, by us or any other party, and I/we waive any claim against and release the District from or for any such loss or damage.

I/we also waive any claim against the District, and hereby release the District from any claim, cause of action or demand that I/we or my Student may have arising out of or in connection with any personal, emotional, psychological, and/or bodily injury, death, or property damage my Student may sustain during the Trip, and agree to indemnify, save, and hold the District harmless from claim, demand, or cause of action of whatsoever nature or kind asserted by or on behalf of my Student for any personal, emotional, psychological, and/or bodily injury, death, or property damage sustained by my Student during the Trip and my Student's participation therein.
