Steele Canyon High School Governing Board Regular Elections to be conducted in August/September 2021

Steele Canyon High School ("SCHS") will be conducting a Regular Election for Community and Certificated Staff Governing Board Member positions in September 2021. The newly elected Board members' three (3) year terms will officially begin in October 2021, upon certification of the election results by the sitting Board. Beginning on August 9, 2021 interested parties will need to submit a Declaration of Candidacy Form, by the August 31, 2021 deadline (no exceptions). Forms are available on the school website and in the front office of Steele Canyon High School. Additionally, each candidate will need to complete and submit a [Candidate's Form 700](#) by the August 31, 2021 deadline which can be accessed through the Fair Political Practices Commission's website at (www.fppc.ca.gov) and in the front office at Steele Canyon High School.

Governing Board Member positions up for Regular Election in August/September 2021:

One (1) Certificated Staff Board Member; and

Two (2) Community Board Members

The [Board Member Election Procedures Policy](#) including, Election Calendar dates, candidate and voter eligibility requirements, will be posted in August at the front office of SCHS and on the school website. The SCHS Election Ad-Hoc Committee is looking for volunteers to assist the Board Secretary, or the Secretary's designee, in overseeing the election process, assist with preparing ballots, and the counting of the ballots. <u>September 13, 2021</u>	<u>Voting period officially begins.</u>
<u>September 22, 2021</u>	<u>VOTING PERIOD ENDS. Last day to receive ballots in the school office by 3:30pm via U.S. mail or hand-delivered, NO EXCEPTIONS.</u>
<u>September 30, 2021</u>	<u>Count ballots and certify the vote – Election Committee.</u>
<u>October 13, 2021</u>	<u>Installation of the new Board Members at the Regular Board meeting.</u>
