Tuition Assistance Applications:

Complete Tuition Assistance Applications are **due by Monday, February 16, 2026 (2025 tax documents are due by April 30, 2026 and June 15, 2026 (if self-employed))**. Tuition Assistance is **only** available towards tuition **for students in Senior Kindergarten to Grade 7**. The link to apply for tuition assistance will be provided in February 2026.
