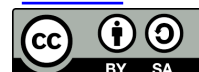

paragraphs should have a first-line indentation of 1.00 cm. The research urgency, supporting facts, and data must be included. A preliminary research result should be explained as the basis of the research. At this point, the novelty will be apparent. The research stance must be included, whether it corrects, debates, or support the previous research.

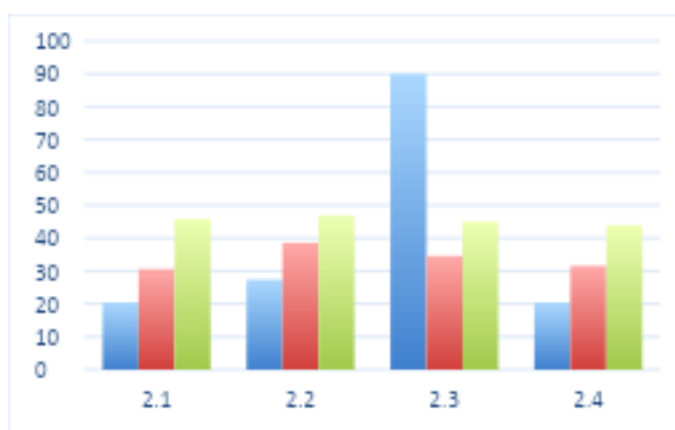


Figure 1. Number of subthemes published in Asesment
