



HSM CLUB FRIEND LICENSE AGREEMENT

This Music License Agreement (“Agreement”) is entered into between **Heavenly Soundz Music (HSM)**, operated by **Edward Lewis Hanserd** (also known as **Edward Hanserd**) (“Licensor”), and the subscribing individual or entity (“Licensee”) enrolled at the **HSM Club Friend** subscription level.

By subscribing to the HSM Club Friend tier, Licensee agrees to the terms below.

1. Grant of License

Licensor hereby grants Licensee a **non-exclusive, non-transferable, revocable license** to use Licensor’s copyrighted musical works released under **Heavenly Soundz Music**, including works distributed via **DistroKid**, for the duration of an active HSM Club Friend subscription.

This license permits use of the music on a **royalty-free basis**, subject to the terms herein.

2. Permitted Uses

During the active subscription period, Licensee **may use the licensed music** for the following purposes:

- Personal listening and enjoyment
- Podcasts and audio programs
- YouTube, Facebook, Instagram, TikTok, and other social media videos
- Livestreams and prerecorded video content
- Church services, worship experiences, and ministry use

3. Ownership & Copyright Notice

Licensee acknowledges that:

4. Credit & Attribution (Recommended)

While not required, Licensee is **strongly encouraged** to credit the music as follows where practical:

Attribution helps prevent automated copyright claims and supports independent worship artists.

5. Restrictions

Licensee may **NOT**:

- Resell, sublicense, share, or redistribute the music files
 - Claim authorship or ownership of the music
 - Register the music with Content ID, PROs, or similar systems
 - Use the music in unlawful, hateful, or defamatory content
 - Allow third parties to download or reuse the music independently

If a platform (e.g., YouTube, Facebook/Meta, Instagram) issues a copyright claim or inquiry, this Agreement serves as **proof of license**.

Licensors may, at their discretion, assist in resolving valid claims for active subscribers.



7. Term & Termination

- This license is valid **only while Licensee maintains an active HSM Club Friend subscription**.
 - Upon cancellation or non-payment, all licensed use must cease.
 - Previously published content may remain online but may not be monetized or reused after termination without renewal.

9. Governing Law

This Agreement shall be governed by and construed under the laws of the **United States and the State of Texas**, without regard to conflict-of-law principles.
