INVITATION TO BID FOR THE PROCUREMENT OF IMMUNE SERA, IMMUNOGLOBULINS AND VACCINES (EPA 2025) IB No. 2025-005

1. The *Tondo Medical Center*, through the *National Expenditure Program* intends to apply the sum of **Ten Million Five Hundred Eighty-Four Thousand Nine Hundred Sixty Philippine Pesos (Php10,584,960.00)** being the ABC to payments under the contract for *Procurement of Immune Sera, Immunoglobulins and Vaccines (EPA 2025)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Tondo Medical Center* now invites bids for the above Procurement Project. Delivery of the Goods as specified on *Section VI*. Bidders should have completed, within *the last three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from the BAC Office of Tondo Medical Center and inspect the Bidding Documents at the address given below during *office hours*.

A complete set of Bidding Documents may be acquired by interested Bidders on **29 October 2024** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount given below*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
