

Services for Ukrainians Abroad

This assistance is divided into two main categories: Services within the country, where the Ukrainians immigrated to and services within Ukraine.

Within Ukraine we provide turnkey legal services for any family law matter, including divorce, alimony recovery, division of marital property, and determining child custody. For this you do not need to notarize and send me a power of attorney for representation, signing an online agreement with me is enough.

I can also represent your interests in divorce proceedings, participate directly in court hearings, and involve you when necessary via the ESITS (Electronic Court) system, following thorough preparation for such hearings.

In exceptional cases, we may consider the possibility of me concluding agreements in Ukraine on your behalf, provided you issue a notarized power of attorney granting me the necessary authority.

The second category are Services for Ukrainians living abroad:

- Liaison with embassies;
- Help with finding local family law attorneys in your area;
- Direct participation in communication and consultations with local attorneys to streamline costs and ensure your case progresses efficiently;
- Preparation of expert opinions on Ukrainian family law for use in foreign court proceedings;
- Valid obtainment of authenticated excerpts from the Family Code of Ukraine through the Ministry of Justice;

- Provision of comprehensive consultations for foreign family lawyers handling your case;
- Assistance in determining jurisdiction.

If you are married to a foreign national or to a Ukrainian but reside in different countries - or if your assets or children are located in different countries - with you seeking my legal advice, drawing on experience from approximately 140 divorce cases, I can quickly analyze your situation, propose the best, fastest and most effective response mechanism, anticipate potential issues common in family disputes, and take steps to prevent them. Remember, consulting a family lawyer in a timely manner can save you both time and money in the future.

Additionally, we can explore the possibility of conducting negotiations if a family member resides abroad while you are in Ukraine, or vice versa. We can also organize a mediation process or review an ongoing case currently being heard in Ukraine to provide an objective external analysis.
