When you provide us with your personal data, it is considered that you are aware and accept the conditions of our Privacy Policy.

Who is responsible for collecting and processing data?

Excelência Refinada LDA, trading as Makan Maderia, hereafter referred to as 'Makan Madeira', is the entity responsible for the collection and processing of your personal data. As part of its business activity, Makan Madeira may use entities it subcontracts to carry out the purposes detailed below.

What is personal data?

Personal data is any information of any nature regardless of its format, including sound and images, relating to an identified or identifiable person. Any person who can be identified directly or indirectly, by reference to an identification number or one or more specific elements of his/her physical, physiological, psychological, economic, cultural or social identity, is considered identifiable.

Which personal data are collected and processed?

How is your data collected?

Personal data may be collected by email, websites or applications, phone calls or In person.

The collected data are processed and stored in electronic form in strict compliance with personal data protection legislation, and are stored in a specific database created for this purpose by Makan Madeira or by the entities contracted by us.

For prospective employees, we will process your data for the following purposes:

14. Recruitment (CV/resume review, application positing, interviews, formal employment offers)

Who is your data

shared with?

The data collected and held by Makan Madeira may be transmitted, with due respect for the duty of confidentiality and the purpose that led to its collection, to the following entities:

- Entities of the group to which Makan Madeira belongs
- Judicial or administrative authorities, in cases where such assignment is mandatory
- Recruitment companies
- Subcontractors who will process the data on behalf of Makan Madeira and for the purposes determined by Makan Madeira.

What are your rights?

Under the terms of the General Regulation of Data Protection, we guarantee you the right to access, update, rectify, delete, transfer and erase your personal data. You may also submit complaints to the National Data Protection Authority.

We also give you the right to object to the use of the data provided for marketing purposes, for sending informative communications or for including them in lists or information services. If you did not do so when the data was collected, you can send a request later.

Is your data processed securely?

Which cookies are used on the website?

This website uses proprietary and third-party cookies. Third-party cookies differ from proprietary cookies in that they are sent to the user's device from a piece of equipment or domain not under the direct management or control of Makan Madeira.

Cookies can be classified as follows:

Essential cookies – These are essential for accessing specific areas of the website. They allow website browsing and the use of applications, such as accessing secure areas via login. These cookies do not collect user information for marketing purposes or for identifying user website visits. Without them, certain services cannot be provided.

Analytical cookies - These analyse how users use the website and can highlight articles or services of potential interest, monitor website performance and determine which pages are the most popular. These cookies are only used to create and analyse statistical information.

Functional cookies – These remember user preferences while browsing the website. Therefore, users do not need to reconfigure or customise each time they visit it.

Advertising cookies – These allow advertising to be targeted according to each user's interests and user habits inside and outside of our website. These cookies are used to provide more focused communication and marketing initiatives, and to help measure advertising effectiveness.
