The writer must demonstrate a causal relationship, citing various information. Important points should be considered: (use 14 pt.)

2.1 The ordering of the content should be continuous to help readers easily understand the content.

2.2 Organizing content so that readers can understand it easily and quickly.

2.3 Critical analysis must be principled. The theory or evidence is based on it correctly according to academic principles. There is a reliable reason. There are references to reliable information.

2.4 Language use must use words in Thai if the Thai words are not yet widely disseminated. Foreign language words should be enclosed in parentheses. In cases where a Thai word cannot be found and needs to be transliterated, that word should be written correctly according to the rules. The Royal Institute should not mix Thai and foreign language. Because it will reduce the formality of the writing.
