A. Regular Meeting Call to Order: W. Hodges called the negotiations meeting to order at 3:31pm

## B. Conduct Collective Bargaining Session with Masconomet Teachers' Association

Attorney Greg Pagnini informed the MTA that the updated proposal from the School Committee mimics the MTA document formatting as requested by the Union. This is a package proposal. Attorney Pagnini reviewed the housekeeping changes and asked the Union for a response to Article 13, and the Union is open to reformatting.

Ad hoc committee meetings are agreed to 4 meetings.

The Parental Leave proposal is one of the top in the state with all unit members entitled to receive benefits. Educator evaluation changes were reviewed. It was agreed to up to 6 unannounced visits. Stipends were updated and reviewed. Attorney Pagnini reviewed the items the School Committee does not agree with. COLA proposed is 3/3.75/4 over 3 years which is tied to the 6 unannounced visits. The increase is across the board to all members. Wage scales and stipend schedules have been updated.

The Union caucused at 3:43pm and returned at 4:35pm.

Eric Blanchet thanked the School Committee for their proposal. The housekeeping notes are agreed upon with 1 counter proposal. Striking "positive" from the "positive feedback visits" and the unannounced visits are separate from other visits. The 6 unannounced visits are to occur during a 2-year period, with no more than 4 unannounced visits in one year.
