Welcome	Dr. K welcomed all to the meeting. SIGN IN SHEET .
Approve Minutes	The committee revised and approved the previous month's minutes .
PBIS-Student Behavior	There was a brief discussion about dress code, particularly as it relates to open- and closed-toed shoes. The committee reiterated that while LAUSD's updated dress code is more flexible and may not expressly require all students and staff to wear closed-toed shoes, Walgrove will still require students to wear closed-toed shoes. One committee member shared that CAL/OSHA likely has rules about employees (other than those in the main office) wearing closed-toed shoes. We will look into this and confirm.
School Calendar and PD Calendar	No items. Dr. K shared that so much of the PD calendar is determined by the District now, as there are so many mandatory PDs.
Budget: Certain General Funds for Instructional Materials; Toshiba contract	The committee formally approved the process for spending the \$25K of CAP Instructional Material Account (IMA) money, which is via a Google doc completed by teachers and staff so that we may expediently spend as much of the \$25K as possible because it does not carry over (should this allocation be under the purview of the LSLC). The committee discussed Michael Stenger's donation to FOW. There were questions about what the money will be spent on. Dr. K said that FOW's mission is to: 1) raise funds for the school and 2) build community. They are not a school decision-making body that can decide for the school, unilaterally, what they will or will not purchase. So, FOW and the school will work together on how to allocate this \$. There are still plans to expand the garden and name the new resulting grove of trees or forest after Michael. "Stenger Grove" or "Stenger Forest." However, FOW and the school are not using his donation for this purpose. Walgrove will strive to use LAUSD \$ for this expansion, as LAUSD has a Board Resolution to turn 30% of all campuses into Green Space over the next decade.

Welcome	Dr. K welcomed all to the meeting. SIGN IN SHEET .
Approve Minutes	The committee revised and approved the previous month's minutes .
SPSA (School Plan for Student Achievement) ...which is a document that Title I schools write to show how they will spend Title I funds to support Title I students. We only complete a portion based on the aspects of the document that pertain to money we receive and/or expectations that come along with being in ATSI Program Improvement.	Reiterated that we are now in Program Improvement because of our 2021-2022 data in these areas: • Chronic Absenteeism (CA) and ELA and Math achievement among Students with Disabilities (SWD) • Chronic Absenteeism among students of Two or More Races (though Chronic Absenteeism among Latinos and Students deemed Socio-economically Disadvantaged (SED) is actually much higher. There is a technicality that makes students of Two or More Races one of our newly supported subgroups) Dr. K reiterated the six strategies outlined in the 2022-2023 SPSA intended to improve attendance, which are: 1) build strong relationships with students and families and capitalize on the strong relationships they already have; 2) foster a welcoming learning environment; 3) build on the richness of what students bring to the classroom; 4) connect the content to the real world and to students' lives; 5) provide rich opportunities for students to engage with one another; and 6) provide timely and appropriate feedback to students on their progress. The committee also reviewed preliminary responses to the 2022-2023 School Experience Survey (SES) and chose specific questions to also focus on for the purpose of future data collection and program evaluation. They are: • I am happy to be at this school. • I feel close to people at this school. • I feel accepted for who I am at this school. • Kids at this school are kind to each other. • There is at least one adult at this school who supports me. • Overall connectedness. • Overall safety. • Students have a voice in decision-making at this school.
