Contact with moving parts	4	4	16	<ol> <li>The immediate area of auguring is to be cordoned off.</li> <li>Be aware of spoil being ejected from the auger during the drilling operation.</li> <li>Do not stand within the immediate auguring area.</li> <li>Open augured holes to be covered or barriered off, by the Principal Contractor, unless piles are to be placed immediately.</li> <li>If practical, erect barriers along the pre-augured line for sheet piling, (pins and net fencing)</li> <li>Backspin spoils into a huge hole if possible.</li> <li>Auger cage to be attached to foot to prevent access whilst auger is turning.</li> </ol>	2	3	6	Project Manager/ Project Engineer/Project Supervisor/Project Safety Officer/MEP Technicians
