Framing and Demands

Rebuild Sanctuary - A Tisha B'Av Action on Immigration

As we mourn the destruction of the Temples in Jerusalem, times of devastating loss and dislocation for the Jewish people, we call on our leaders to actively resist the federal assault on the dignity, safety and wellbeing of immigrants in our community. We reject the weaponization of Jewish fear into a tool for dismantling civil liberties and instead uphold the tenets of our faith that compel us to protect and stand with marginalized communities. To rebuild sanctuary in the Commonwealth, we ask that our Massachusetts elected officials—including Governor Healey and members of the legislature—to do everything in their power to:

- Publicly resist the weaponization and bad-faith use of antisemitism as a tool to crack down on civil liberties and higher education
- Disrupt the detention of immigrants in inhumane conditions at the Burlington ICE Office and stop Massport cooperation with ICE deportation flights from Hanscom airport
- Support state legislation to terminate state contracts funneling money and resources into the deportation machine, and ban new and existing contracts (using the Dignity Not Deportations Bill - H.1588 & S.1122). This includes terminating the existing 287g contract with the Department of Corrections and ending the Intergovernmental Service Agreement with Plymouth County Correctional Facility.

Secondary policy asks:

- <u>The LUCE Coalition Demands</u>, including restoring COVID-19 era remote participation in our courthouses for hearings/proceedings in order to protect immigrants from being detained during regular court proceedings
- Invest money in frontline communities, not a \$360 million dollar new women's prison or other carceral infrastructure (pass the Prison and Jail Construction Moratorium)
