Current Tuition Waiver

Deer Park School District #82 provides a non-resident pupil tuition rate. Deer Park School is highly regarded in the region with small class sizes and effective learning implementation. This waiver allows pupils to attend Deer Park School and utilize its rich academic resources and environment.

Tuition Waiver Agreement of Understanding

It is agreed that your child may attend Deer Park Community Consolidated School District #82 as a non-resident student for the school year conditional on the following:

1. All enrollment information is accurate.
2. There is no significant change in the student's behavior or characteristics which would deter your child's being a "good fit" for the appropriate classroom at Deer Park School.
3. Prompt payments are made to Deer Park CCSD #82.

Annual tuition rate 2024-2025= \$3,400 for one child plus \$80 registration fee

Monthly tuition rate 2024-2025= \$377.78

Reduced tuition rate 28% for addition child \$2,448 for each additional child plus \$80 registration fee
