For reference, our ad Hoc committee purpose based on the motion that passed last month is:

If you discuss it please refer to it as Safety Exploration as we don't want people to misunderstand it as an actual safety resource which World CoDA has

- 1. Discuss safety in meetings, the 12 Traditions, look at the Dealing with Disagreements pamphlet, read what is in the FSM about safety, look at the ACA 8 steps dealing with abusive people, the new ACA 13th Step tent card, Gambler's anonymous safety plan, SLAA scripts, etc and learn from other 12 step fellowship's experience.
- 2. Create clear steps to take when a person is abusive in a group and safety suggestions for a healthy group conscience, hoping to make both a metaphor to use in relationships. Also create a writing with general safety suggestions for navigating CoDA.
- 3. Discover if we create a pamphlet, optional meeting reading, or a webpage (or combo) and say that this is something local LA CoDA is trying out for a year or two and if it benefits our community, we'll pitch it to world to become CoDA approved. (This is what NorCal did with the 30 questions over the course of ten years)

- If it's a WW number, it will be discovered globally it can also be on local meeting list as long as they try to / do have a GSR and list their meeting in Pacific time
- Had voted previously that we'll re-assess in December 2022

Events

- Been a while since we've had an event and would be great to do something to reinvigorate the fellowship and get people to the new meetings
- Could be impactful to have an Intergroup longtimer be a guest speaker to talk about the importance of the committees and being a chair or co-chair
- Meeting that had been virtual just had an in-person meeting at Pan Pacific, we had a sound bath and meditation, did shares, read some literature, and then fellowship
- Will take a little while to plan have something accessible and meditative
- Too late to do marathon meetings in November/December flyers would have needed to go out in August, and it was so stressful for the people planning it
- Last year for "marathon" meetings, we each contacted different people from different meeting days and asked if they'd be willing to be the intergroup "Thanksgiving" meeting and then the meetings did group consciences and voted on it
- Marathon meetings are somewhat outdated because it was to have extra resources during the hard times of holidays but we all have access to zoom meetings all over the world now
- Great idea of voting in each meeting if they a) want to hold the meeting during the
 holiday and b) want to open the meeting up during the holidays even if it's typically for a
 specific segment
- Super important to have an official point of contact for the respective holiday meetings because the typical point of contact may not even be joining or available
- IF COMFORTABLE, EVERYONE CAN GO AHEAD AND START ASKING IN MEETINGS IF THEY WANT TO VOTE ON BEING THE HOLIDAY MEETING IF IT FALLS DURING A HOLIDAY TIME
