Fire.	Slips, trips & falls. Burs, scalds & smoke inhalation.	All persons entering or using the site.	In the event of a fire you should raise the alarm, get out, stay out and call the fire brigade. Please ensure all of your group are aware of the fire evacuation procedures. The fire assembly point for the whole site is at the flagpole in the centre of the field. Users of the campfire circle or firelighting area should be supervised by a sensible responsible person at all times. Water buckets are present in the campfire circle & firelighting area, users are responsible to ensure that they are filled up before use of the area.	Butchers Coppice Operations Team. The woodpile.	Falling from height. Stepping on nails or other objects causing injury. Cuts, abrasions and other injuries.	All persons entering or using the site.	Climbing in the woodpile is prohibited. Persons entering the woodpile must be wearing boots with thick soles. Groups must be supervised by a suitable responsible person while in the woodpile. Suitable signage displayed.	Site Staff. Group Leaders.
Trees	Unintentional fire spread.	All persons entering or using the site.	Fires must be supervised and controlled by a sensible responsible person. Water buckets are present in the campfire circle & firelighting area, users are responsible to ensure that they are filled up before use of the area.
