Swampscott School Committee Regular Session Minutes

October 27, 2022

A meeting of the Swampscott School Committee was held in Room B129 at Swampscott High School in Swampscott, MA commencing at 6:00 p.m. with the following members present: Mr. Glenn Paster, SC Chair, Mr. John Giantis, SC Vice Chair, Ms. Amy OConnor, Ms. Suzanne Wright and Ms. Carin Marshall. Also, Present: Pamela Angelakis, Superintendent of Schools; Martha Sybert, Director of Finance. Student Representative Afia Bottari and Jessie Goodwin were absent.

The public will be able to attend virtually in accordance with the Executive Order issued by Governor Baker on March 12, 2020, and extended through March 31, 2023, suspending certain provisions of the Open Meeting Law G.L. c. 304, Section 20. The meeting was recorded and broadcast live on the local cable station.

Mr. Giantis - none.

Ms. OConnor reminded all of the upcoming High School Drama presentation. A. Superintendent's Report

i.Academic Excellence Award - S. Andrews

Ms. Angelakis gave a bio of Samantha Andrews and presented her with a certificate.

Ms. Angelakis gave the Committee an overview of the commendation and congratulated Samantha Andrews and Jad Oubala for their accomplishments. Mr. Paster congratulated both on their accomplishments.

iii. Recommendation for Director of Finance

Ms. Angelakis reminded the Committee that the current Director of Finance, Martha Sybert would be leaving the District on December 1. She introduced Cheryl Herrick Stella to the Committee and offered her recommendation for Ms. Herrick Stella as the new Director of Finance. She explained that she would be starting on January 23rd and that Ms. Sybert and Ms. Herrick Stella would be working on the transition. Mr. Paster congratulated Ms. Herrick Stella and welcomed her to the District. Mr. Giantis added that they had all met via Zoom and all were excited that Ms. Herrick Stella was onboard. Ms. Wright stated she was looking forward to working with Ms. Herrick Stella on the School Building Committee. Ms. Herrick Stella

vi. October 1 Enrollment Report

Ms. Angelakis reviewed the enrollment numbers at each school level as well as reviewed the In-District and Out-of-District placement numbers. There was a discussion regarding a potential increase of Special Education tuition placements and the concern about funding for the increases and Ms. Angelakis stated she would forward a document she received. Mr. Paster stated he would reach out and invite our representatives to a future meeting to Discuss as well. Ms. OConnor said she would extend the invitation to the Finance Committee as well. Mr. Giantis questioned the number of withdrawn students. Ms. Angelakis stated the number of withdrawn is typically equal with the new student registration and she would present the new student registration report at a future meeting. There was also a discussion regarding METCO enrollment and looking toward increasing enrollment with the new school building.

Mr. Paster stated the Committee welcomed any sort of communication via email but reminded all to also ce the Superintendent to keep her in the loop.
