Distribution, Posting and Advertising

- ❖ **You cannot** distribute my work on any third-party resources.
- ❖ **You can** post my work ordered by you in your gallery only with a link to my profile.
- ❖ **You cannot** use any of my works for commercial purposes in any way.
- ❖ **Credit needs to be given to:** **Ligynkey** (FA,DA,Inkbunny, etc.)

General Terms

- ❖ **You can** consult for a commission without obligation.
- ❖ **English is not** my native language, mine is **ru~~ss~~ian**, so keep it in mind.
- ❖ Unspecified details or major changes **will have a fee** to compensate for the extra work.
- ❖ **I have the right to reject** any order if I don't want to make it.
- ❖ If we have some troubles during the work, **I have permission to cancel** the commission, after return only half of the price and the customer can be **blacklisted**.

Ordering, slots

- ❖ Ask me in PM, if you interested to get a commission or slot
- ❖ You can claim slot in open auctions (comment section)
- ❖ To make a commission, **you must give me next information:**
- ❖ - *Description of what you want*
- - *Character reference (or art with describing some of the details)*
- - *Special details (background, pose, emotions, etc.)*
- ❖ *Feel free to attach all necessary references for the job.*
- ❖ *Artistic freedom can be used.*
- ❖ Slot will be awarded after the payment.
- ❖ **I start work on the commission only after full payment!***
- ❖ **Payment plans are allowed, if the commissions price is 100\$ or high*

Payment

- ❖ **Full payment upfront, no exceptions.**
- ❖ Payments will be made via Paypal/Hipolink (USD\$)
- ❖ I can use invoice.
- ❖ **No commission will be started without full prepayment.**
- ❖ *You can drop me some tips on commission payment. ^w^*

Work in Progress

- ❖ Small changes **can be done** in the sketch stage. Major changes (pose, character, etc.) after sketch **will have an extra** payment.
- ❖ I can send W.I.P.s if it will be asked for.
- ❖ Final work will be given in HQ .png
- ❖ Nothing changes after the final result and submitting (I can change only miniman mistakes)
- ❖ I work only in my own styles, I don't copy styles of other artists.
- ❖ All the final works have my sign and you are not allowed to remove it.
- ❖ I don't work with deadlines. The time to complete a commission can be from days to months. It depends in these factors:
 - - Health
 - - Studying
 - - Mood
 - - Travelling
 - - Emergencies

Refund Policy

- ❖ A commission will be fully refunded only if I decide to cancel it when I did not start.
- ❖ A commission in process **cannot be** canceled, therefore it cannot be refunded.
- ❖ I will refund half of the price if we have some troubles.
- ❖ I can not refund after finished commission.

Copyright / Use policy

- ❖ I, as an Artist, have all the rights of all of my produced artwork. The client **does not have** rights to my artwork.
- ❖ The client can:
 - Post my work with credits to me (read the begin of ToS)
 - Use only in personal use
 - Print and claim the rights of your characters
 - The client is not allowed to use in commercial purposes
 - If the client infringes the copyright rules in any way, all the rights granted to him will be withdrawn.
- ❖ An infringement is considered:
 - - Trying to remove my sign
 - - Reproduction, using my artwork commercialy
 - - Take credits for creating the artwork
 - - Trying to change art without my consent

Blacklist

- ❖ Any person who is blacklisted **cannot be** commissioned and lose all the rights of commissioned artwork.
- ❖ If client is trying to offend (or just inadequate) - **will be blacklisted**
