Teague ISD Parental Involvement Policy

TISD Mission Statement

The mission of the Teague ISD is to educate to the fullest extent possible all children attending our schools. We will strive to do this through quality of instruction, equity for all students, and accountability and improvement of our instruction. All students will develop essential academic skills and knowledge based on which to build life-long learning. Citizenship, economic responsibilities, and an appreciation of our American heritage, including its multicultural richness, are important factors in the education of our children. All facets of the TISD education community will seek continual improvement in our educational endeavors.

Statement of Purpose

Teague ISD is committed to the goal of providing quality education for every student in the district. To this end, we want to establish partnerships with parents and with the community. Neither home nor school can do the job alone. Parents play an extremely important role as the children's first teachers. Their support for their children and for the school is critical to their children's success at every step of the way.

The purpose of parent involvement is to promote a school-home partnership that will help all students on all campuses succeed. Everyone gains if school and home work together to promote high achievement for our children.

Grade-level goals for the students of Teague ISD will be distributed to all parents in the district, with the expectation that all students will work toward these goals. We recognize that some students may need the extra assistance available through the Title I program, as well as other programs, to reach these goals.

- 1. The LEA –Local Education Agency/School District involves parents in the joint development of the district's plan and the process of school review and improvement. Teague ISD intends to include parents in all aspects of the district's Title I Program and Parental Involvement Policy. The goal is a school-home partnership that will help all students in the district succeed. Parents and district personnel will meet to develop our district's Parental Involvement Policy. Parents will be invited from each school attendance zone in our district to be part of the process. Special attention will be given to recruiting parents of children participating in the Title I Program.
- 2. The LEA will provide the coordination, technical assistance, and other support necessary to assist participating schools in planning and implementing effective parent involvement activities to improve student academic achievement and school performance.

Teague ISD will provide support and training to principals and teachers to promote parent involvement activities.

3. Build the schools' and parents' capacity for strong parent involvement.

In order to build a dynamic home-school partnership, Teague ISD, with the cooperation of the campuses, will provide the following:

- An annual meeting where parents will learn about the requirements of the school's Title I program, and be given an opportunity to become involved with their child's education. The annual meeting will be held during the first twelve weeks of the school year.
- Parent meetings and conferences held at different times during the day to accommodate the needs
 of the parents. Communications with parents will be in a format and language they can
 understand.
- A description and explanation of the curriculum used, the forms of academic assessments used to measure student progress (benchmarks, TPRI, etc.), and the proficiency levels students are expected to meet, will be provided to parents through a letter or conference.
- Assistance to parents in understanding the state's academic content standards, known as the Texas
 Essential Knowledge and Skills and the state student achievement standards based on the State of
 Texas Assessments of Academic Readiness (STARR), will be communicated through
 school-wide meetings and a letter from the principal.
- A school-parent compact designed by parents and school staff that outlines how parents, the
 entire campus staff, and the students will share the responsibility for improvement in student
 academic achievement.
- A minimum of one scheduled parent conference where the school-parent compact will be discussed as it relates to the progress of the student, as well as the expectations for the grade level school curriculum, test information, and any other concerns the teacher or parent may have.
- Parents will have the opportunity to help review, plan for, and make suggestions to improve the Title I program, as well as the Parental Involvement Policy and the SchoolParent Compact.
- Appropriate parent participation opportunities for regular meetings to formulate suggestions and
 to participate, as appropriate, in decisions relating to their child's education. Parents may request
 a meeting with the principal by phone, e-mail, or in writing. In addition, parents may attend the
 scheduled yearly and semester meetings.
- Information relating to school and parent programs, meetings, and other activities will be sent to parents in a timely manner. Information will be given to parents through newsletters from the school, PTO, and the classroom teacher. In addition, the school marquees will be used to inform parents of dates of programs, meetings, and activities.
- Materials and specific training to help parents work with their children to improve achievement.

Parents and community members are always welcome at our schools. By using their suggestions to improve our schools and by working together, we can make all the students in our school successful learners.

- 4. Teague ISD, to the extent feasible and appropriate will coordinate and integrate Title I, Part A parental involvement strategies with parental involvement strategies under other programs, such as Head Start, Reading First, Early Reading First, Even Start, Parents as Teachers, and Home Instruction Programs for Preschool Youngsters, and state-run preschool programs through joint meetings and parent nights.
- 5. Teague ISD, with the involvement of parents, conducts an annual evaluation of the content and effectiveness of the District Title I Parental Involvement Policy with regard to: -improving the academic
