
# **Ukrainian Classical Musicians Support Fund by KCMD**

### Groups of applicants, their needs, and current location

Date: July 12, 2022. Number of applicants: 683 people. Prepared by Polina Horodyska

### 1. Groups of musicians

The majority of the Support Fund applicants are musicians who are in Ukraine and not employed (283 persons, 41.4 %). A smaller number of applicants are musicians who are in Ukraine and employed (206 persons, 30.2 %). The smallest group of applicants comprises elderly musicians and musicians with disabilities who are in Ukraine (47 persons, 6.9 %). Musicians who were forced to leave Ukraine due to the war make up 21.5 % (147 persons).



#### 2. Current Location

#### 2.1. Countries


Applications from the musicians who were forced to leave Ukraine due to the war make up a fifth part of all the applications: 21.5 % (147 persons).

When applying, the musicians were located in the following **26 countries**:

Austria, Belgium, Bulgaria, Denmark, Estonia, Indonesia, Ireland, Spain, Italy, Latvia, Lithuania, Moldova, the Netherlands, Germany, Poland, Slovenia, Slovakia, Hungary, Ukraine, France, Croatia, the Czech Republic, Montenegro, Switzerland, Sweden, Japan.

The largest number of applicants is currently in **Poland** (26.67 %), **Germany** (20 %), **Austria** (10.37 %), Italy (8.89 %), as well as in Spain (4.44 %), Czech Republic (2.96 %), and Slovakia (2.96%).

## 2.2. Regions of Ukraine

**Musicians currently located in Ukraine** compose **78.5** % (536 persons) of all the applicants as of July 12, 2022.

The Fund received applications from the musicians located in the following **24 regions of Ukraine**: the Vinnytsia, Volyn, Dnipropetrovsk, Donetsk, Zakarpattia, Zaporizhzhia, Zhytomyr, Ivano-Frankivsk, Kyiv, Kirovohrad, Luhansk, Lviv, Mykolaiv, Odesa, Poltava, Rivne, Sumy, Ternopil, Kharkiv, Kherson, Khmelnytskyi, Cherkasy, Chernivtsi, and Chernihiv regions. There were no applications from the Autonomous Republic of Crimea only.


The largest number of applicants that stay in Ukraine is located in the following localities:

- 1. Lviv region 18.25 %, 98 people. Localities: Drohobych, Zymna Voda, Lviv (88.3 %), Malechkovychi, Nahoryany, Shchyrets, Stebnyk, Chervonohrad.
- 2. Kyiv region 17.32 %, 93 people. Localities: Bezradychi, Bila Tserkva, Brovary, Gatne, Irpin, Khotianivka, Kyiv (70.11 %), Novosilky, Pereyaslav, Sofiivska Borshchahivka, Tetiiv, Yahotvn.
- 3. Dnipropetrovsk region 8.94 %, 48 people. Localities: Dnipro (52.17 %), Kamianske, Kryvyi Rih, Pavlograd, Pokrov.
- 4. Kharkiv region 7.08 %, 38 people. Localities: Vesele, Lozova, Kharkiv (92.11 %), Chuhuiv.
- 5. Zakarpattia region 5.96 %, 32 people. Localities: Mukachevo, Tiachiv, Uzhhorod (92.86 %).

### 3. Needs

More than half of the applicants (63.84 %) request "the provision of one-time financial assistance for civil needs in the amount of UAH 3,400" ("Need 3"). About 25 % of the musicians request this type of support combined with "Ensuring a basic standard of living and security: food, medicine, housing, etc." (around 10 %) and "Meeting the musicians' needs to keep their practice going" (around 15 %).

Ensuring a basic standard of living and security: food, medicine, housing, etc.

#### Need 2.

Meeting the musicians needs to keep their practice going.

#### Need 3.

Providing one-time financial assistance for civil needs in the amount of UAH 3,400.

## 4. Needs and Groups of musicians

The request for "the provision of one-time financial assistance for civil needs in the amount of *UAH 3,400.*" is the most common and prevails for all four groups of musicians with whom the Fund works.

Need 1. Ensuring a basic standard of living and security: food, medicine, housing, etc.

## 4. Groups of Needs

The vast majority of requests from Ukrainian academic musicians are aimed at **ensuring a basic standard of living** for applicants. Around 15 % of the applications contain requests to support other people (family members, people under their guardianship, acquaintances, refugees, teachers). Less than 1 % of the applicants request money for the needs of the Armed Forces of Ukraine.

The detailing of requests stated in the applications allows to single out the following groups of needs: professional needs, musical instruments; job search; medicine, treatment; housing; food; personal hygiene products; clothing and footwear; education; utilities; fuel.

The largest number of applicants ( > 28 %) have lost their source of income because of the war and/or forced relocation, both inside and outside the country, and they are looking for a job.


The second largest in volume (20.06 %) is **the list of professional needs** of applicants, among which is the demand for resources for the purchase, repair, and rental of musical instruments, equipment, scores, etc.

Need 2. Meeting the musicians' needs to keep their practice going: i.e. maintaining instruments in a proper condition, buying an inexpensive instrument in case of loss, and other urgent professional needs.

Need 3. Providing one-time financial assistance for civil needs in the amount of UAH 3,400.

The list of top five the most urgent needs also includes **food** (18.89 %), **medicine and treatment** (16.11 %), **housing** (14.06 %). Applicants also state the need for clothing and footwear (6.3 %), resources and opportunities for vocational education (4.98 %), request assistance in paying for the utilities (4.54 %), purchase of personal hygiene products (3.07 %), and purchase of fuel (1.02 %).

Among the most urgent needs of **the musicians who were forced to leave Ukraine due to the war**: Job Search (44 persons, 30.77 %); Professional needs, musical instruments (25.17 %); Food (11.89 %); Medicine, treatment (11.89 %); Housing (10.49 %); Clothing and footwear (6.99 %); Personal hygiene products (4.2 %). About 6% of the applicants need help with resources and opportunities for vocational education.
