#### **ENGLISH VERSION**

# By commissioning me in any way shape of form, you are agreeing with the following terms:

## **GENERAL**

- I retain the right to refuse or cancel a comission at any time
- Please be polite when speaking with me, languages such as english, portuguese and spanish may be used when discussing the project
- I retain full rights to the comissioned artwork. If you wish for the artwork to not be used as portfolio pieces, physical print pieces or wish to request a NDA or Copyright Commercial License, please state it in the appropriate field.
- Editing, tracing, copying or altering the artwork in any way, shape or form, is NOT allowed (unless discussed otherwise. It is strictly forbidden to claim the artwork as your own.
- Using the artwork for pyramid schemes such as NFTs, Bitcoin, Cryptocurrencies, and or Generative AI (or similar) is strictly forbidden and will not be tolerated.
- I am able to mimic artstyles from ONLY visual media such as animes, series, games, etc. I will NOT copy another artist's artstyle. Please consider that I have my own style when comissioning me.
- Sharing the comissioned artwork is allowed, for commercial licenses, crediting must be discussed beforehand.

#### **PAYMENTS**

- Quotes may be requested at any time and free of charge, however they have a valid period of 1 month. Past the limit date, a new quote must be requested.
- Payment must be done within 48hours, failure to do so and the comission is cancelled.
- Payment plans may be requested, but require the piece to cost a minimum of 100€. Limit dates for payments are to be discussed before payment.

# **REVISIONS**

- Revisions are allowed at any period of the artwork, however, abusive request of changes will be charged with a fee
- WIPS are constantly sent as I work on the comission, if I have not sent a first sketch within a month of the comission request, please contact me
- Significative changes after the final image is delivered will be charged a fee

#### **DEADLINES AND DELIVERY**

- Waiting time varies according to the current number of clients and depend on the comission type. The expected turnaround for bigger pieces go up to 3 months (depending on the project). Smaller pieces like icons may go up to 1 month.
- If you wish to have the artwork ready on a certain date, please discuss it beforehand with me. Depending on the timeline given, a fee will be charged accordingly.
- Priority is given to those who have paid earlier.

#### **REFUNDS**

- I have the right to cancel and refund your comission at anytime
- Refunds may be requested at any time, however, depending on the state of the artwork, only a partial refund will be issued.

• If a chargeback is issued against me, all rights to the artwork are revoked and I am allowed to resell the piece to another client.

### **INTELLECTUAL PROPERTY RIGHTS and USAGE**

- I retain all copyright and ownership rights to the artwork, such as but not limited to display, share and make physical prints of. A NDA may be discussed and agreed upon before the project is complete. Such a license comes with a fee.
- Client is allowed to use the piece for profile picture display, banner display, personal
  printing for enjoyment, and any other situation where it is not considered commercial
  use (see below).

#### **COMMERCIAL LICENSE**

- Commercial use is not allowed unless the customer previously discussed and paid for a commercial license. The cost of the license will be determined considering the complexity and usage of the piece.
- The following is considered commercial usage: streaming, selling, promotion or creation of content, branding, merchandise creation, book publishing, media publishing, videos. Its is not limited to these and they should be taken as examples.
- When a commercial license is in place, the artist retains rights to the piece creation, which means you may not claim it as made by yourself.
- Discussing a license for usage of the piece in crypto projects and Generative Al projects will NOT be accepted and may not be requested.
