Preamble

On the 14th January [REDACTED], Ethics Committee Assistant Julien White, personal assistant to the late Chairman Remmy Marshall, went missing from Site-65. Omega-1 teams were immediately deployed to investigate and report their findings, with Ethics Committee Member Andrew Whitaker taking charge of the incident.

JULIEN WHITE - FINDINGS

Julien White is marked as Killed-in-Action, impaled within a tree in a lost corridor within Site-65, barely alive. His last words - a dying declaration; O5-10 is the culprit and Mr. White had dug too deep, he knew too much. Ten said he had to go.

Following the 14th January, a further incident occurred later in the month on the 23rd. A disappearance of similar nature of J. White occurred - this time Vice Chairman Isaiah Cimmerian's body was found in a cryptic tomb, solidified in stone. Three individuals were identified to be connected with this event:

- Senior Researcher Morikas Laritho
 - O5-10 "The Iconoclast"
 - "NOVEMBER"

Following MTF Omega-1 ("Law's Left Hand") deployment to the site after field operatives reported their entry into the same tomb, they attempted to capture Overseer Ten per Mr. Whitaker's order. They ultimately failed, with two operatives being killed by the lone operative known as "NOVEMBER" and Ten demanding all troops retreat, threatening the use of an eigenweapon against the Committee. Whitaker decided to comply for the sake of preservation of life and noted his findings, with Omega-1 being put on Alert Grade II in light of the hostility.

MORIKAS LARITHO - PERSONNEL REVIEW

Not much information has been identified about Senior Researcher Laritho apart from their connection to O5-10's work and Ten's personal testimony that Mr. Laritho is an important part of one of his projects.

"NOVEMBER" - PERSONNEL REVIEW

This individual was identified to be a nondescript mercenary reporting to O5-10 himself - the only identifying trait being their robotic and monotonous language used when speaking. They are noted to have heightened awareness of their surroundings and also greater access to foundation systems, including some channels of Omega-1's communications. They are suspected to be part of MTF Alpha-1, detailed personally to Ten.

This lapse in informational security should be reviewed.

Primary Incident

On the 25th January [REDACTED], Mr. Whitaker had ordered the immediate detainment of Senior Researcher Morikas Laritho due to their connection to the disappearances of Mr. White and Mr. Cimmerian. After being captured without incident, they were interrogated thoroughly to attempt to find their connections to Ten and find out what he was up to with his involvement in two Committee deaths. Throughout the interrogation, there was irregular interruption from an unknown source which was destabilising the hume levels and causing intense migraines in operatives involved. This interruption was identified to be as a result of "NOVEMBER", with him being sighted on two occasions nearby, attempting to capture Mr. Laritho. With this, Mr. Whitaker made the decision to kill Morikas Laritho as he was deemed to be too dangerous.

What ensued shortly afterwards can only be described as insanity. The mercenary described as "NOVEMBER" unleashed a tirade of attacks on MTF Omega-1 throughout the Site-65 Ethics Committee Offices, killing [REDACTED] Omega-1. The motive of this attack is assumed to be as a result of Morikas Laritho's execution, although the goal of the attack is undetermined - analysts do not agree with the perception that "NOVEMBER" did it out of any sort of emotional outburst. It is presumed that "NOVEMBER" left the site without any sort of injuries, somehow.

After the attack had ended, Mr. Whitaker raised the alert level to Grade I. This means that no Ethics Committee Members are permitted outside of a secure area without a form of escort from MTF Omega-1. Whitaker followed this protocol and decided to review some documentation later in the day, unbeknownst to him, the attack was not over.

Andrew Whitaker was targeted in a dimensional attack lodged by the sole unit "NOVEMBER", being torn from the baseline dimension and an alternate one. MTF Omega-1 successfully retrieved Mr. Whitaker through reality anchoring methods, although this success was only temporary, and Mr. Whitaker was abducted later in the day and could not be reached. Unusually, "NOVEMBER" argued with MTF Omega-1 in their communications channels and provided frequent status reports. Transcripts show the following:

"[WHITAKER] IS [SAFE]"
"[WHITAKER] IS [FINE]. STAND DOWN"

These messages took a dark turn, with the following two transmissions being made shortly later:

"[WHITAKER] IS NOT [SAFE]"
"[WHITAKER] IS [GONE]"

Return

Ethics Committee Member Andrew Whitaker's geolocation device was suddenly pinged on the 14th January [REDACTED] within Site-65's stretches of maintenance tunnels. His body was located slumped over, unconscious, though vitals were reported to be strong. Upon being taken to the medical bay, an examination proved a large gunshot wound in his chest from a revolver-like firearm that had been patched up in a makeshift fashion using staples. Whitaker was returned to the offices to debrief Chairman Remmy Marshall.

FINDINGS

Whitaker spoke slurred words, in a daze, constantly mixing the past and present in a manner only consistent with Post Traumatic Stress Disorder. The following facts were ascertained:

- Whitaker was taken to an unknown location and spoke to Ten through some sort of monolith.
 - Ten scalded him for getting in the way of his plans.
- Ten was working on an operation to dissolve the SCP Foundation and let anomalies roam free.
- Two men entered the room, one identified as "NOVEMBER", and another was an unidentified male in a cape.
 - "NOVEMBER" permitted Mr. Whitaker one final transmission to anybody of his choosing.
 - The unidentified man then shot Whitaker, presumably killing him.
- The unit known as "NOVEMBER" then saved Mr. Whitaker's life against the orders issued to him. The motive for this is still unknown. See RECOVERED-DEVICE-001.

RESPONSE

Andrew Whitaker has been placed in Chairman Marshall's personal pocket dimension (Area-05) for his safety from O5-10 until such a time as he can return to active duty. He has been stripped of all clearance and the title of Ethics Committee Member until O5-10 is brought to justice for the crimes he has committed against the Committee and the Foundation. After which, he can be issued AMN-E269 (E-Grade) amnestics to forget the events and rid the PTSD that has clouded his judgement.

Description

The recovered device measures 15cm in height and 5cm in width and is identified as a digital audio recorder which was located in the pocket of Andrew Whitaker's bloodied blazer with a single recording recovered. The recording approximated to be 18 hours in length with a file size of 10 Gigabytes. Based on the make and model of the audio recording device, the recording had only stopped because it reached its maximum storage capacity of 10 Gigabytes. Most of the audio recording consists of a quiet hum comparable to a ceiling fan or air conditioning unit, however a short conversation was recorded approximately 7 hours in from the beginning.
