

## BRAG AGM 15 January 2026

**Extraordinary Item** – Rob Dembrey is a local resident, researching for a book on the Great War and Kingston and has been investigating local participants who died fighting in WW1 – aiming to find out more about the individuals involved – their lives and how they came to fight in the War and details of their death as well as local Kingston social history from the time. He shared some fascinating information on his findings – the book is due out in November, “One road in the Great War”. BRaG is keen to share ideas and opportunities to promote and help support the publicity. Initial ideas include an event as part of the May Merrie, as well as an evening author event closer to the book launch. Will be tabled on the agenda for the next BRAG Committee meeting.

### **Chair intro and highlights from last year:**

The chair thanked the committee and volunteers, committee meeting hosts, Pete for leading Treasury, Secretarial support from Lucy and Sarah, Comms support from Glen and Jules. The committee recognized the sterling efforts of Jo as an exceptional chair and as ever; Father Martin for the support of St Lukes; and Katy Mepham for her work as charity liaison and for hosting the committee Christmas party.

Recognition was also given to Charlie Lynch for delivering all the BRaG promotional material as part of his DoE Gold.

The Chair summed up our 2 events successfully held in 2025:

#### 1. May Merrie:

- This was the second May Merrie, a great event again, enjoyed by all who attended, with lots more new, young families from the wider community, in line with our BRaG Committee ambitions. The Pie larks and Morris Dancers very well received, including a Maypole and Park Brewery Hog Roast for the first time. We raised more than last year (£941 vs £591) through careful shopping, cost control and re-using the games which we invested in last year.
- The event will be run again in 2026 on Saturday May 2<sup>nd</sup> with The Pielarks and Morris Dancers already confirmed. Further planning to be agreed at our next Committee meeting.

#### 2. Oktoberfest:

- Another great event which raised nearly 60% more than last year (£4122 vs £2671) predominantly due to Higher sales (+15%) and lower costs (-24%). The food, bar and music were enjoyed by all including lots of families with young children who came in the early evening.
- The event will be run again in 2026, with a proposed date of Saturday 3rd October.

BRAG were proud to donate £4500 to our 3 below charities in 2025 (further details in the Treasury update below). The Chair highlighted that BRAG have delivered £74k in total to charities since we started in 2011 – a fabulous achievement to celebrate.

- St Luke's Church
- Kingston Food Bank
- Barnfield Riding for the Disabled.

We look forward to selecting and supporting our chosen charities this year – see below.

**Treasurer update:** Accounts have been reviewed by Caroline Rand (with thanks) and will be appended to these minutes. Caroline will continue for 2026 but would like BRaG to find a replacement auditor for 2027.

2025 saw our highest revenue for the 2 events run, eg for Oktoberfest with £6144 revenue vs £3649 in 2024. We were more efficient with our purchasing, reusing assets and strong cost control but also events were very well attended with good spend and maximising revenue opportunities.

Donations of £500 via Sewing Angels, direct donations and Amazon in addition to payments for renting BRaG equipment e.g. tents/marquees.

£8644 total revenue, £3716 total costs with £4500 donations to our 3 charities, retaining £428. An additional donation from 2024 was made to our charities for £1500. Our remaining balance is £2000.

Thanks to Laura for her role as Deputy Treasurer, with apologies for not being able to resolve the banking access issues.

Thanks were received from Heather for her get well flowers.

IT and internet expenses have increased but cover us for the next 3 years.

**BRAG relationship with St Lukes:** Father Martin formally retires on 18 October and timing for a replacement is unknown. The Patron of the diocese is the Bishop of Southwark who also retires this year. A case will be put in for BRaG and the continued relationship with St Lukes as a community asset. BRaG should invite the ArchDeacon to planned events for 2026 to see the value first hand of our community events (with early notice to encourage attendance). A formal farewell will be held at 18 October Evensong – however BRaG would like an opportunity to formally thank Father Martin and our appreciation for the support of the church.

### **Charity nominations:**

A second communication will be distributed with a link to a google form – residents will be asked to confirm they live on the BRAG streets and given a first choice and second choice. Each member of the household will be allowed to vote (regardless of age). The committee also agreed that during the year on an ad hoc basis we may choose to support other charities on a practical basis to leverage our reach and generosity of our local community, e.g. food bank donations, Xmas Operation Goldfish etc.

It was agreed that a subset of the committee would proactively visit our chosen charities to build relationships and offer practical support (in addition to donations) as appropriate.

**\*Previous Extraordinary Item for discussion by a Sub-Committee** – Should BRAG consider responding to major planning applications that will likely affect BRAG residents in some way both during and post-construction?

Di Watling (North Kingston Forum) introduced the motion for debate and posted 4 questions to be answered relating to BRAG's involvement in manor planning applications:

1. Informing BRAG membership of any major planning applications submitted that could potentially affect BRAG roads. **AGREED BY THE COMMITTEE THAT THIS IS ALREADY IN ACTION**
2. Encouraging the BRAG membership to consider responding to a major planning application if the above point is true. **AGREED BY THE COMMITTEE THAT THIS IS ALREADY IN ACTION.**
3. The committee to respond to a major planning application should committee members feel that BRAG roads would be affected in some way. **It was agreed that the BRAG committee would need to solicit feedback from members to ask if there are any objections to BRAG sending in a representation to the council. This would need to be done rapidly (given the deadline for response to the planning application) and could be done via email. The BRAG response would be focusing on the environmental and pollution impacts directly resulting from the increase in traffic due to the development. This is in line with our constitution point 4.**
4. Consider sending a potential BRAG response to their membership for their information before submitting to the council
