## THE AIMS OF THE NEWLY MERGED LAW/LIEN GROUP

- [1]---To oppose the witch-hunt against the left in all its forms, whether inside or outside the Labour Party.
- [2]—To connect all those on the left, both inside and outside the Labour Party, who want to fight back

against the current attempts to push the party to the right, and keep together in comradely solidarity all those who believe in "For the Many, Not the Few."

- [3]—To support and connect left activists who want to advance their activism in local groups, regardless of the direction of travel of the current Labour leadership.
