ARTICLE I. NAME AND AFFILIATION

The name of this corporation shall be Lincoln Land High School Prep Hockey League. (referred to hereinafter as "LLPHL"). LLPHL shall be affiliated with AHAI and USA Hockey.

ARTICLE II. OFFICES

- 2.1 The principal office of LLPHL shall be in the State of Illinois. LLPHL may have such other offices, either within or without the State of Illinois, as the business of the corporation may require from time to time.
- 2.2 The registered office of LLPHL required by the General Not-For-Profit Corporation Act to be maintained in the State of Illinois may be, but need not be, identical with the principal office in the State of Illinois, and the address of the registered office may be changed from time to time by the Board of Directors.

ARTICLE III. PURPOSES

- 3.1 To develop, encourage and regulate the game of ice hockey as a high school sport in the State of Illinois for the benefit of, and exclusively for, students and their respective schools, and so the sport is made available to more students at the lowest possible cost.
- 3.2 To develop and encourage sportsmanship and playing proficiency by all high school member players involved in the sport of ice hockey in the State of Illinois.
 - 3.3 To obtain future recognition of hockey as a sanctioned high school sport.
- 3.4 To encourage academic and athletic excellence in all high school ice hockey players.
 - 3.5 To affiliate with and registrar of all teams with USA Hockey.
- 3.6 To conduct high school ice hockey tournaments and to sanction teams to enter and participate in said tournaments.
- 3.7 To secure financial assistance and to receive gifts/donations from any source whatsoever to be used solely for said purposes.
- 3.8 To do any and all acts necessary or desirable in the furtherance of the foregoing purposes.

ARTICLE IV. MEMBERS

- 4.1 ANNUAL MEETING The annual meeting of the member teams shall be held each year, no later than June 30th, for the transaction of such business as may come before the meeting.
- 4.2 MEMBERSHIP The members of LLPHL shall comprise all the amateur high school varsity ice (AHAI) hockey teams as defined in the LLPHL Rules and Regulations, and in accordance with the USA Hockey By-Laws, headquarters in the State of Illinois and such other teams as may be designated to be under the jurisdiction of LLPHL.
- 4.3 SPECIAL MEETINGS Special meetings of the member teams may be called by the President or a majority of the Board of Directors.

- 4.4 PLACE OF MEETING The President of the Board of Directors may designate any place within the State of Illinois as the meeting place for any annual meeting or for any special meeting.
- 4.5 NOTICE OF MEETINGS Written or printed notice stating the place, day, time, and agenda of the meeting, and in the case of a special meeting, the purpose for which the meeting is called, shall be delivered no less than seven (7) days before the date of the meeting to each member team entitled to vote at such meeting. If mailed, such notice shall be deemed to be delivered when deposited in the United States mail, addressed to the member team at its address as it appears on the records of LLPHL, with postage prepaid.
- 4.6 Quorum Fifty percent of the member clubs eligible to vote shall constitute a quorum at any meeting of member teams provided that, if less than 50 percent of the voting member club are represented at said meeting, a majority of the member teams so represented may adjourn the meeting from time to time without further notice. If a quorum is present, the affirmative vote of the majority of the voting member teams represented at the meeting shall be the act of the members.
- 4.7 VOTING Votes shall be cast by the representative of the member club listed as the official designated spokesperson, unless another representative has been designated, in writing to president, by the member team, provided however such designee must be affiliated with the same association as the member team. Except as set forth above, no proxy voting shall be permitted. Voting on any question in any election shall be by voice or written ballot. All votes shall be a matter of public record and duly recorded by the Secretary.
- 4.8 VOTING DISPUTES At any meeting of the member clubs any question or dispute relating to the validity or result of any vote shall be submitted to the incumbent Board of Directors for a determination and the decision of the majority of the Board present, provided a quorum of the Board is present, shall be binding of all parities.

ARTICLE V. DIRECTORS

- 5.1 GENERAL POWERS The business and affairs of LLPHL shall be managed by the Board of Directors.
- 5.2 SPECIFIC POWER The Board of Directors shall determine what is in the best interest of high school ice hockey and shall have the authority to develop, implement, and enforce rules, policies, procedures, incentives, and penalties that advance those interests. Furthermore, the LLPHL Board of Directors shall have the authority to name, at its discretion, one or more Directors Emeriti in recognition of outstanding service to this Association. Emeriti shall continue to be non-voting members of this Board of Directors and eligible for all committee appointments by the President.
- 5.3 NUMBER, TENURE, AND VACANCIES The number of Directors of LLPHL shall not exceed 9, excluding Ex-Officio members, as elected by the voting member teams.
- 5.4 OFFICERS The officers of this Association shall consist of a President, a Vice President or Vice Presidents (s), Treasurer, Secretary, Immediate Past President and

such other Officers as may be elected or appointed by the standing Board of Directors on or after July 1st of each year.

- 5.4.1 PRESIDENT The President shall be the chief executive officer of the Association and shall, in general, supervise and control all of the business and affairs of the Association. He/she shall preside at all meetings of the Board of Directors and the voting authorized by the Board of Directors, any deeds, mortgages, bonds, contracts, or other instruments which the Board of Directors has authorized to be executed, except in cases where the signing and executing thereof shall be expressly delegated by the Board of Directors or by these By-Laws. He/she shall perform all duties pertinent to the office of President and such other duties that may be prescribed by the Board of Directors from time-to-time. The President shall represent the Association in any local, state, or national meetings, as well as any meetings with any member organization where his/her presence is desirable, as well as be the authorized spokesman to the media for the Association. The President shall appoint chairman for all committees and shall serve as an ex-officio member on all committees.
- 5.4.2 VICE PRESIDENT (S) In the absence of the President or in the event of his/her inability or refusal to act, the Vice President shall perform the duties of the President, and when so acting, shall have all of the powers of and be subject to the restrictions upon the President. In the event that there shall be more than one Vice President, the Vice President in the order designated, or in the absence of any designation, then in the order of their election, shall serve in the absence of the President.
- 5.4.3 TREASURER The Treasurer shall have charge and custody of and shall be responsible for all funds and securities of the Association; receive and give receipts for all moneys due and payable to the Association from any source whatsoever, and deposit such moneys in the name of the Association in such banks, trust companies, or other depositories as shall be selected in accordance with the provisions of these By-Laws.

At least once a year, but no later than the annual meeting, the Treasurer shall give a full and complete financial report, including, but not limited to, a balance sheet and income statement of the current fiscal years activities. In general, the Treasurer shall perform all duties pertinent to the office of Treasurer and such other duties as may be assigned from time-to-time by the President or Board of Directors.

5.4.4 – SECRETARY/REGISTRAR - The Secretary shall keep the minutes of the meetings and any membership meetings and of the meetings of the Board of Directors in one or more books provided for that purpose. The Secretary shall see that all notices a duly given in accordance with the provisions of these By-Laws or as required by law. The Secretary shall be the custodian of the Association records and keep a register of the post offices addresses of each member of the Board of Directors, all officers of the Association and all officers/representatives of the Association members. In general, the Secretary shall perform all duties as may from time-to-time be assigned by the President, or the Board of Directors.

- 5.4.5 LEAGUE SCHEDULER The Scheduler shall work with all affiliated programs to provide a game schedule for the league. Any unforeseen scheduling conflicts will need to be resolved with the League Scheduler.
- 5.4.6 ALUMNI-AT-LARGE The Alumni-At-Large shall be a former team representative who no longer has a child participating in the league.
- 5.4.7 HEAD OF OFFICIALS The Head Of Official shall be a current IHOA certified official. Duties include working with the League Scheduler to provide officials for all league games as well as communicating any on-ice issues to league referees.
- 5.6 PROCEDURE FOR NOMINATION Nominations for the Board of Directors shall be made from the floor by any team representative and/or a nominating committee appointed by the Board of Directors at a meeting of member teams no later than April of each year. Such meetings shall be open to all member teams. The President shall open and close nominations for each position individually.
- 5.7 -ELECTION The member teams of the Association at the Association annual meeting shall elect the members for the Board of Directors. All members of the Board of Directors may succeed themselves in office. The Board of Directors may be elected from among or from outside the member teams. All other officers shall be appointed by the President and must be approved by the simple majority of the Board of Directors.

The Australian ballot system shall be utilized for the election of the Board of Directors. The President shall see that a ballot is prepared listing the candidates and respective positions. The voting procedures as set down in Section 4.7 of these by-laws shall be followed. The Team Representative unable to attend the election will issue absentee ballots upon written request to the President.

- 5.8 REMOVAL Any member of the Board of Directors elected or appointed may be removed from office by either a two-thirds (2/3)-majority vote of the entire Board of Directors or by a three-fourths (3/4)-majority vote of the member teams.
- 5.9 VACANCIES A vacancy in any elected or appointed office because of death, resignation, removal, disqualification, or otherwise may be filled by a majority vote of the Board of Directors for the unexpired portion of the member teams.
- 5.10 REGULAR MEETINGS A regular meeting of the Board of Directors shall be held without other notice than this by-law, immediately before, or after, and at the same place as the annual meeting of the member teams. The President or a majority of the Board of Directors may provide, by resolution, the time and place, for the holding of additional regular meetings without other notice than such resolution.
- 5.11 NOTICE Notice of all meetings shall be given by written notice delivered personally by postage mail to each director at his/her business or home address, by telegram, or by telephone electronic mail may be used as a suitable method. Any director may waive notice of any meeting. The attendance of a director at any meeting shall constitute a waiver of notice of such meeting.

- 5.12 VOTING Each director shall be permitted one vote and such vote shall be by voice vote, recorded by the Secretary. Voting by proxy shall not be permitted.
- 5.13 QUORUM A majority of the number of Directors will constitute a quorum for transaction of business at any meeting of the Board of Directors provided that, if less than a majority of such number of directors are present at said meeting, a majority of the directors present may adjourn the meeting from time to time without further notice.
- 5.14 MANNER OF ACTING The act of a majority of the Board members present at a meeting at which a quorum is present shall be the act of the Board of Directors.
- 5.15 OTHER DUTIES The Board of Directors shall hear and rule on appeals from any of the members of this Association and shall resolve any and all disputes within the Association and its members. The Board of Directors shall hear and rule on all other matters as provided for elsewhere in these by-laws or in the Rules and Regulations.
- 5.16 PARLIAMENTARY PROCEDURE Roberts Rules of Order shall govern and control the conduct of all meetings of the LLPHL unless modified by these bylaws.
- 5.17 EXONERATION FROM PERSONAL LIABILITY The LLPHL hereby consents and declares that each officer, member of the Board of Directors, chairpersons and members of all committees, and all elected or appointed officials in any capacity shall be deemed to have assumed office or assignment on the express understanding, agreement and condition that each one of them and his/her heirs, executors and administrators, estate and effects respectively shall from time-to-time and at all times be indemnified and saved harmless out of the funds of the LLPHL from and against all liabilities, judgments, costs, charges, and expenses whatsoever which member sustains or incurs in or about any action, suit or proceeding which is brought, commenced or prosecuted against him/her for and in respect to any act, deed, matter or thing whatsoever made, done or permitted by him/her in or about the execution of the duties of his/her office and also from and against all other cost, charges and expensed which he/she sustains or incurs in or about or in relation to the affairs thereof, except such costs, charges or expenses as are occasioned by his/her own willful neglect or default.

ARTICLE VI. COMMITTEES

- 6.1 STANDING COMMITTEES The President with the approval of the Board of Directors shall designate and appoint individuals to a Rules Committee and Disciplinary Committee and such other committees deemed necessary or appropriate to the efficient conduct of this Association.
- 6.1.1 RULES and DISCIPLINARY COMMITTEE The Committee shall have jurisdiction for hearings and rulings on appeals for infractions of the LLPHL by-laws, infractions occurring on the ice, as well as all matters which arise out of competitive play or directed to be heard by the Board of Directors. In all cases, a majority of the members of the committee shall constitute a quorum.
- 6.1.2 AUTHORITY OF THE R&D COMMITTEE The Committee shall have the authority to suspend, place on probation, or impose other disciplinary sanctions against any person, team, or organization which it determines to have violated the By-Laws or Rules and Regulations of LLPHL, AHAI or USA Hockey Inc. Duration of suspensions shall be determined by this committee. Decisions of this committee shall be final unless a notice of appeal is filed as provided for within the Rules and Regulations.
- 6.1.3 R&D COMMITTEE It shall also be the responsibilities of the Committee is to review the playing rules of the game, to review the Rules and Regulations of the LLPHL, to review proposals for changes that are brought forth by various members and committees, to and make their recommendations known to the Board of Directors.

In all cases, a majority of the members of the committee shall constitute a guorum.

ARTICLE VII. FINANCES

- 7.1 CONTRACTS The Board of Directors may authorize any officer or officers, agent or agents, to enter into any contract or execute and deliver any instrument in the name and on behalf of LLPHL, and such authority may be general or confined to specific instances.
- 7.2 LOANS No loans shall be contracted on behalf of LLPHL and no evidence of indebtedness shall be issued in its name unless authorized by a resolution of the Board of Directors. Such authority may be general or confined to specific instances.
- 7.3 CHECKS, DRAFTS, ETC. All checks, drafts, or other orders for the payment of money, notes, or other evidence of indebtedness issued in the name of LLPHL, shall be signed by such officers or officers, agent or agents of LLPHL and in such manner as shall from time-to-time be determined by resolution of the Board of Directors.
- 7.4 DEPOSITS All funds of LLPHL not otherwise employed shall be deposited from time-to-time to the credit of LLPHL in such banks, trust companies or other insured depositories as the Board of Directors may select.

ARTICLE VIII. WAIVER OF NOTICE

Pursuant to the Corporation Act of the State of Illinois, a waiver thereof in writing, signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be deemed equivalent to the giving of such notice.

ARTICLE IX. RESOLUTION OF DISPUTES

- 9.1 RESOLUTION Resolution of disputes shall be handled at the direction of, or by the Board of Directors of this Association under appropriate by-laws of USA Hockey Inc. concerning jurisdiction; procedure for arbitration of disputes; and concerning such procedure being the exclusive remedy.
- 9.2 CIVIL OR INJUNCTIVE ACTION Any member team, organization, or individual which files, or causes to by filed, any civil or injunctive, action in any Court of Law against USA Hockey Inc. or LLPHL shall immediately be suspended and/or disqualified from membership in this organization.

ARTICLE X. FORMAT FOR CHANGING BY-LAWS

- 10.1 PROPOSALS . Proposals will not be accepted after the season begins and only after that season play has been completed will proposals be accepted. Any member school representative or member of the Board of Directors may propose amendments to these by-laws by submitting the same in writing to the President and to the Secretary and such will be considered and approved or disapproved at the next meeting of the Board of Directors.
- 10.2 MEETINGS Proposed by-law amendments may be considered and voted upon by the Board of Directors at either a regular or special meeting. However, the notice of such meeting, whether regular or special, shall notify each director and each member school of the proposed amendment.
- 10.3 ACTION Amendments may be approved by a majority of the directors present and voting at which a quorum is present and, if so approved, shall be adopted and, if so disapproved, shall be rejected.

ARTICLE XI. PLAYER ELIGIBILITY

- 11.1 High School Player Restricted to amateurs who are full time students in good standing (grades 9 through 12), and under 20 years old on December 31st of the Playing Season, not to exceed eight (8) consecutive semesters starting with the freshman year, who are enrolled and attending the school designated on the team's and player's registration.
- 11.1.2 Transferring students Any student that transfers from any one school to any other after the start of the school year will: A.) Have a thirty (30) day waiting period if the student had not tried out or played on the hockey High School Team of the first school the same year or B:) Have a one year waiting period if the student had tried out or played on the hockey High School Team of the first school in the same year. This applies to transfers between any two schools whether they be public or private.
- 11.1.3 Home school students Home Schooled and Online High School student requirements for participation in a High School Affiliate Organization, either pure or

combined, will require proof of enrollment in an accredited High School program as well as proof of residency within the public-school boundary based on their home address. This only applies to public schools with defined borders. Private Schools do not have defined boundaries and therefore are not considered to be home schooling or online education.

Players may stay eligible by carrying a full load of classes for four (4) consecutive years from their start date as a freshman with no breaks. If all criteria are met, they may be approved by the AHAI Registrar on the roster for the High School Affiliate Organization in which the public school is part of. Home-schooled and Online High School students who wish to be approved to participate with a program must notify the High School Committee Chair of their request and provide the required information/documentation prior to being approved on a roster.

- 11.2 Players not attending high school or in their fifth year since initially attending high school are not eligible.
- 11.3 Players rostered or participating at Junior hockey are not eligible to play. AAA Tier 1 players are not eligible to play on JV Roster
- 11.4 Any player that owes past monies to any team or hockey association for any reason will not be allowed to play in LLPHL until the matter is resolved. Written notification between the teams or associations involved will be required.

11.5 – Suspensions/Academics

- 11.5.1 if a player is serving a school suspension, they may not participate in LLPHL events until the school suspension has been served.
 - 11.5.2 A player must be taking the required number of classes.
- 11.5.3 As outlined in the Code of Conduct, it is the responsibility of the player and/or the player parents/guardians to inform their affiliated club coach/manager of school suspensions. Failure to be forthcoming will result in a review by the Rules and Discipline Committee. The committee will determine any additional suspensions.
- 11.5.4 As outlined in the Code of Conduct, it is the responsibility of the player parents/guardians to ensure their player is performing to the best of their ability academically. In instances where they are not, notify the coach/manager that the player will not be participating until their academics improve to an acceptable level.

ARTICLE XII. TEAM RULES AND ASSIGNMENTS

12.1 - Affiliate club teams and players must be properly registered and rostered with USA Hockey and AHAI. Team rosters must be signed and completed prior to the first scheduled league game. Players added to the team roster after the first scheduled league game must be in accordance to AHAI rules and regulations, and approved by the LLPHL Board.

12.2 - All coaches must be registered, rostered, and comply

with current USA Hockey and AHAI certification requirements.

12.3 – LLPHL and affiliate clubs must practice the following team selection process:

Absolutely "NO" cutting of players. Reasonable efforts are made to invite all eligible players from the assigned schools of the opportunity to play in LLPHL

- 12.4. Clubs with only enough players for one team must play Varsity unless given exception by LLHPL Board.
- 12.5 A player must play for the affiliated club of the high school thev attend.
- 12.6 Homeschool players will play for the public school they would attend based on their residency.
 - 12.7 Cross Roster Varsity
 - 12.7.1Players all come from the same school or program
 - 12.7.2Players may play "UP" on their Varsity program
 - 12.7.3 Each Club may have a max of 15 Cross roster players
 - 12.7.4 Players who are not cross-rostered will be frozen to Varsity or JV
 - 12.7.5 JV TEAM NOT eligible for State Varsity Invitational Tournament but all JV players are eligible to join
 - 12.7.6 Varsity for the state tournament Cross Roster Players MAY play with JV team the entire season as well as the Varsity program
 - 12.7.7 In order to be eligible for the postseason Players must play in 50% of their clubs Varsity LPHL regular season schedule

ARTICLE XIII. GAME ADMISSION FEES

- 13.1 The home team is responsible for setting the cost of admission. An admission fee is not required.
 - 13.2 The admission fee cannot be more than \$5 per person
 - 13.3 The home team keeps all money collected.
