App Powered by Pushpay

Personal information we collect

The personal information that we collect about you through the App depends on how you interact with us:

- *Information that you provide voluntarily*

- *Information that we collect automatically*

The App may also collect information about how your device has interacted with the App, including the pages accessed and links clicked.
