

RELEASE AND INDEMNITY

In consideration of the right to enter the Lawther - Deer Park Prairie Preserve (L-DPPP) owned by the Native Prairies Association of Texas (NPAT), I, individually and on behalf of my children, release, acquit and forever discharge NPAT, its chapter(s), its officers, servants, other volunteers, agents, or employees (hereinafter referred to as RELEASEES) from any and all claims or causes of action of any kind whatsoever, at common law, statutory or otherwise, that may arise from my or my children's use and entry upon such lands. This Release shall include any accident, incident or occurrence proximately caused by the negligence of the RELEASEES.

Further, I understand that in any event involving activities in nature there is a certain risk of injury. I hereby acknowledge that the organizers have given me warning that the events they are sponsoring may involve pot holes, rough footing, wildlife such as ticks, wasps, other biting or stinging insects and snakes, plants that may have thorns or cause contact dermatitis or other allergies, tripping hazards from vines, and other unforeseen hazards. I have taken into account my own and/or my children's physical condition prior to my participation in these activities.

I further agree that I, my children, and our heirs, successors and assigns, will not make any claim or institute any suit or action at law or equity against the RELEASEES arising from any such accident, incident or occurrence.

I, individually and on behalf of my children, further agree to protect, indemnify and hold harmless RELEASEES for any loss by them arising from any acts by me, or my children whether negligent or not, while we are upon or are using the L-DPPP.

I UNDERSTAND THAT BY SIGNING THIS RELEASE AND INDEMNITY, THAT I HAVE AGREED, INDIVIDUALLY AND ON BEHALF OF MY CHILDREN, NOT TO BRING SUIT OR ASSERT ANY CLAIM AGAINST THE RELEASEES EVEN THOUGH WE OR OUR PROPERTY ARE INJURED OR DAMAGED AS A RESULT OF THE NEGLIGENCE OF THE RELEASEES, THEIR GUESTS OR WHILE WE ARE UPON OR ARE USING THE OWNED LANDS OF THE LANDOWNER. I ALSO UNDERSTAND THAT WE HAVE AGREED TO INDEMNIFY, PROTECT AND HOLD HARMLESS THE RELEASEES FOR ANY ACTS BY ME OR MY CHILDREN WHICH CAUSE DAMAGE OR INJURY WHILE ANY OF US ARE ON LANDOWNER'S LANDS.

The term "my children" shall include my own children, wards, and any other children in my care while upon Landowner's property.
