Editorial Essay OVERVIEW

Purpose & Characteristics of Editorial writing

"An editorial is an article that presents the newspaper's <u>opinion</u> on an issue. It reflects the majority vote of the editorial board, the governing body of the newspaper made up of editors and business managers. It is usually unsigned.

Much in the same manner of a lawyer, editorial writers



build on an argument and try to persuade readers to think the same way they do.

[An Op-ed., on the other hand, is an essay in a newspaper or magazine that gives the opinion of the writer and that is written by someone who is not employed by the newspaper or magazine. The **purpose** of the editorial essay is to write about a topic that matters to you]. Editorials are meant to influence public opinion, promote critical thinking, and sometimes cause people to take action on an issue. In essence, an editorial is an opinionated news story" (Resource: Geneseo Writing Center). You will combine *rhetorical techniques* and writing skills to produce a well-written editorial using *credible sources* to provide a convincing argument about your self-selected topic.

Process:

There will be <u>a timeline for various due dates</u> regarding the essay (will be distributed this 1/22 when we begin researching and completing source cards). Due dates are subject to change according to classroom progress regarding coverage of certain requirements and weather related issues. You will be expected to participate in and complete activities (such as source finding, outlining, drafting, peer-editing and revisions) that are part of the process of writing this paper daily in class for the next few weeks. In addition, anything that is not completed in class must be completed on your own.

Grading:

Each of these assignments will be graded and some will be counted as **HW and/or** minor assessment grades for the remaining of Quarter II. The final draft of the paper itself will be counted for **ONE major assessment grade (counting for Quarter III).**

REQUIREMENTS:

- A. <u>Viewpoint:</u> Editorial states a clear opinion and issues a call to action through argument based on evidence.
- B. **Evidence:** Editorial uses compelling evidence to support the opinion, and cites reliable sources
 - a. Writers must use at least 3 (CREDIBLE) outside sources that relate to their topic and support/counter argue their claims. At least one source must be from the NY Times newspaper. Sources can include books, newspapers, scholarly journals, magazines, PRE-APPROVED Internet sites, personal interviews, court documents, textbooks, etc.
 - b. Writers **must incorporate the rhetorical strategies** covered in our unit: **logos, ethos, and pathos.**
- C. **Analysis and Persuasion:** Editorial convincingly argues point of view by providing relevant background information, using valid examples, acknowledging counter-claims, and developing claims -- all in a clear and organized fashion.
- D. <u>Language</u>: Editorial has a strong voice and engages the reader. It uses language, style and tone appropriate to its purpose and features correct grammar, spelling and punctuation.

E. **Guidelines**:

- a. Editorial follows all contest guidelines, including a maximum word count of 450 words and inclusion of at least one Times and two non-Times source. (*This may be tough!!*).
- b. Final essay must be typed in MLA format: double spaced, 12-point font of the following font styles ONLY: Times New Roman, Arial (not Arial narrow, black or bold) or Candara. Paper must have one-inch margins on all sides with correctly formatted heading, page numbers and works cited page (citing your minimum 3 sources.)
