Parents For Grown-Ups

Parents For Grown-Ups (“we,” “our,” or “us”) values your privacy. This Privacy Policy explains how we collect, use, disclose, and protect your information when you use the Parents For Grown-Ups mobile application and website (collectively, the “Service”).

1. Information We Collect

a. Information You Provide

We may collect the following information when you create an account or use the Service:

- Email address
- Name or nickname
- Profile information (age range, preferences, bio)
- Profile photos (optional)
- Messages and content shared within the app
- Support inquiries or communications

b. Automatically Collected Information

- Device type and operating system
- App usage and interaction data
- IP address (for security and fraud prevention)
- Approximate location (city/region only, if enabled)

c. Payment Information

All payments are processed through Apple’s In-App Purchase system. We do **not** store or process credit card or financial information.

2. How We Use Your Information

We use your information to:

- Provide and maintain the Service
- Create and manage your account
- Enable matching, messaging, and community features
- Facilitate in-person and virtual events
- Improve app functionality and user experience
- Ensure safety, moderation, and compliance with community standards
- Respond to support requests

We do **not** sell your personal data.

3. Analytics

We may use analytics tools to understand how users interact with the app. Analytics data is used to improve performance and features and may be aggregated or anonymized.

4. Advertising & Tracking

Parents For Grown-Ups does **not** use third-party advertising networks.

We do **not** track users across apps or websites, and we do **not** use Apple's Identifier for Advertisers (IDFA).

5. Data Sharing

We may share information only in the following limited circumstances:

- With service providers who support app functionality (e.g., hosting, moderation tools)
- To comply with legal obligations or protect user safety
- With user consent

All service providers are required to protect your data.

6. Data Retention

We retain personal data only as long as necessary to provide the Service or comply with legal obligations. Users may request account deletion at any time.

7. Your Rights

Depending on your location, you may have the right to:

- Access your data
- Correct inaccurate information
- Request deletion of your account
- Withdraw consent

8. Security

We implement reasonable technical and organizational safeguards to protect your data. However, no system can be 100% secure.

9. Children's Privacy

Parents For Grown-Ups is intended for users **18 years and older**. We do not knowingly collect data from children under 18.
