Abstract

The abstract should be written in one paragraph and should be not more than 250 words. Times New Roman, font size 10, single spacing. Follow the following pattern: General statement about the importance of the topic, gap in literature or discrepancies between theories and practices, purpose of study, method, main findings, and result. Abstracts are made in 2 languages, English and Indonesian.

Keywords: Keyword one, keyword two, keyword three, keyword four, keyword five – Times New Roman, font 9, single spacing (no more than two lines)

INTRODUCTION

In Introduction, Authors should state the objectives of the work at the end of introduction section. Before the objective, Authors should provide an adequate background, and theoretical frameworks which are used in order to discuss the problems as the objective of the research to show which is the best of previous researches, to show the main limitation of the previous researches, to show what do you hope to achieve (to solve the limitation), and to show the scientific merit or novelties of the paper. Avoid a detailed literature survey or a summary of the results. The article should be between 10-13 pages, single spaced, 11 point Times New Roman font, excluding references and appendices. Use no indent for the first paragraphs and do not leave a space between paragraphs. The following paragraphs is indented first line 1 cm.

In Methods, Authors should state the methods which used in the research by very short literature survey in order to record the existing solutions/method.

RESULT AND DISCUSSION

Results should be clear and concise. In the Discussion, it is the most important of your article. Make the discussion correspond with the finding but do not reiterate the discussion.

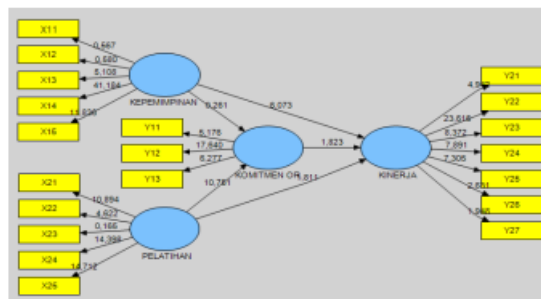
